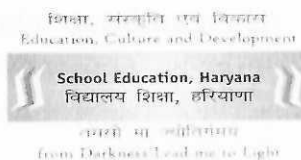

ORDER

Terms and conditions:-

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.

4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate from issuing authority. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is found false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter educational qualification certificates be got verified from the issuing authority within 03 months. If in the verification it reveals that any certificate is found false then your appointment will be cancelled without any notice.
9. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
10. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
11. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
12. No TA/DA will be admissible to the candidate for joining as PGT.
13. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.

14. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
15. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisional of Indian Penal Code (IPC) etc as deemed fit.
16. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/08/2022-3GS-III dated 23.06.2022 and 52/06/2018-2HR-III dated 05.02.2024.

ORDER

Order No. 9/145-2022 Pen.1 (3)

Dated, Panchkula

Whereas the petitioner had filed the CWP No.20653 of 2025 titled as Vishal Kumar V/s State of Haryana and Others in the Hon'ble Punjab And Haryana High Court, Chandigarh praying therein for issuance of a writ, order or direction especially in the nature of Mandamus directing the respondents to consider the case of the present petitioner for appointment on compassionate grounds as his mother expired on 22.05.2022 during her duty period.

The above mentioned Civil Writ Petition came up for hearing before the Hon'ble Punjab And Haryana High Court, Chandigarh On 23.07.2025 and the same was disposed of with following direction:-

“...Accordingly, the present petition is disposed of with the consent of the parties and without commenting anything on the merits of the case, by directing respondent No.2 to consider and decide the legal notice dated 11.03.2025 (Annexure P-6) by passing a reasoned and speaking order within a period of four months of the receipt of certified copy of this order.”

In compliance of the above said direction of the Hon'ble High Court, the case the petitioner has been examined. Petitioner was engaged as a part time class-IV in 20.07.2002 GPS, Kithwari District- Palwal against unsanctioned post of class-IV & the services of the petitioner had been regularized by the department vide Order dated 10.07.2017 and she died on 22.05.2022. That the relevant parts of the Haryana Civil Services Compassionate Financial Assistance or Appointment Rules, 2019 are as under:-

4. (1) The family member shall be eligible for consideration of compassionate appointment under these rules subject to the condition that the deceased or missing Government employee should,—

- (i) have completed five years service on regular basis;*
- (ii) have not attained the age of fifty-two years or more upto the date of death or missing; and*
- (iii) not be suspected to have committed fraud or joined any terrorist organization or gone abroad.*

Explanation.— Five years service includes the period of all kinds of leave sanctioned by the competent authority and availed by the deceased or missing Government employee while working on regular basis.



As per 2019 rules 5 year regular service is required for the claim of employment. Mother of the petitioner has not completed five year requisite regular service, she join as a regular employee 10.07.2017 and she died on 22.05.2022. Further, the Haryana Government, General Administration Department Notification dated 2nd August, 2019, which provides inter alia as under:

(3) Save as otherwise provided, these rules shall be applicable to the eligible family member(s) of a Government employee working on regular basis and All India Service Officers who disappears or dies while in service including death by suicide.

Note-1: The family of a deceased Government employee who died before the date of notification of these rules but have not been sanctioned the compassionate financial assistance by the competent authority due to one reason or the other, may exercise an option within a period of six months from the date of notification either to avail the benefit under the Haryana Compassionate Assistance to the Dependents of Deceased Government Employees Rules, 2006 or under these rules. The option once exercised shall be final.

That the financial assistance under the Haryana Compassionate Financial Assistance rules has already been sanctioned on 05.12.2022 and released to the family of the deceased employee. It is pertinent to mention here that as per Note-1 of the Haryana Government General Administration Department Notification dated 02.08.2019, the family of a deceased Government employee was required to exercise the option for ex-gratia (compassionate) appointment within a period of six months from the date of notification. However, in the present case, no such claim or request for ex-gratia appointment was received by the department from the family of the deceased employee within the stipulated period of six months.

Therefore keeping in view the above said facts and rules applicable in the case claim of the petitioner is not tenable and is liable for rejection being devoid of merits.

I pass order accordingly.
