Whereas FIR No. 207 dated 11.08.2022 under Sections 420, 467, 468, 471, 447, 120 B of IPC was registered against Shri Satish Kumar Sangwan [092934] Clerk O/o District Education Office, Faridabad [4606] at Police Station SGM Nagar, Faridabad. Thereafter, vide order dated 16.07.2024, the Ld Court of Judicial Magistrate, 1st Class, Faridabad held him guilty and sentenced as under:-

Thereafter, he filed an appeal against the order of the Ld Trial Court before the Ld Court of Additional Sessions Judge, Faridabad. The Ld Appellate Court has suspended the sentence of the appellant and the order dated 08.08.2024 passed in CRA 219 of 2024 by Ld Additional Sessions Judge is reproduced as under:-

"4. Hence, the order of Sentence passed by the Ld trial Court, is hereby suspended, till the disposal of the appeal in hand or, till further order, whichever may be earlier, subject to furnishing bail bonds in the sum of Rs. 50,000/- each with one surety in the like amount"

That the Ld Appellate Court has only suspended the sentence vide order dated 08.08.2024 in CRA 219 of 2024 but there is no stay on the conviction of the accused/clerk and thus, the provision of 311(2)(a) of Constitution of India are attracted in the case which is reproduced as under:-

" 311. Dismissal, removal or reduction in rank of persons employed in civil capacities under the Union or a State

(1) No person who is a member of a civil service of the Union or an all India service or a civil service of a State or holds a civil post under the Union or a State shall be dismissed or removed by a authority subordinate to that by which he was appointed

(2) XXXXX

(a) where a person is dismissed or removed or reduced in rank on the ground of conduct which has led to his conviction on a criminal charge; or....



That Shri Satish Kumar Sangwan [092934] Clerk O/o District Education Office, Faridabad [4606] was convicted by Ld Court of Judicial Magistrate, 1st Class, Faridabad and has been sentenced to undergo punishment of 2 years and fine under Sections 420, 467, 468, 471, 120 B of IPC. The Ld Appellate Court in its order dated 08.08.2024 in CRA 219 of 2024 has only suspended the sentence but there is no order of stay on conviction. Further, the act of Shri Satish Kumar Sangwan [092934] Clerk O/o District Education Office, Faridabad [4606] is duly covered in Rule 5(ix) of Haryana Civil Services (Government Employee Conduct) Rules, 2016 being convicted in the aforesaid criminal case.

In view of the above, Shri Satish Kumar Sangwan [092934] Clerk O/o District Education Office, Faridabad [4606] is hereby dismissed from service by invoking the provision of Rule 311(2)(a) of Constitution of India.
