Accordingly, after going through the facts, reply of delinquent and record of the file, it has been found that she did not have proper staff, so, I am of the considered view to file the present chargesheet with warning to remain careful in future.

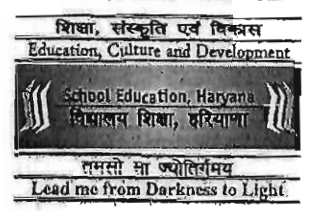

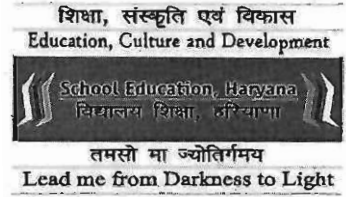

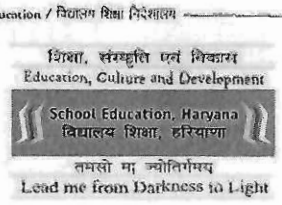
