Whereas, the District Education Officer, Bhiwani has forwarded a case of Smt. Asha [203987], PGT Pol. Science, GSSS Kirawar (Bhiwani) now posted at GSSS, Ratera [0398] Bhiwani for treating of suspension period w.e.f 11.03.2022 to 23.06.2023 as the period spent on duty to the Department for consideration/order.

Whereas, a complaint was filed against Smt. Asha [203987], PGT Pol. Science wherein it was alleged that the delinquent discouraged the students of the school with regard to the Vaccination of Corona and un-necessarily told students about the adverse effects of the vaccination. Ultimately, the vaccination team returned back without vaccination of children, thus she obstructed the vaccination programme which was in public interest. Vaccination team reported to their higher officers that Smt. Asha is discouraging the students from Vaccination against Corona. The SMO concerned filed an FIR No. 12 dated 12.01.2022 against her and she was suspended with immediate effect vide order No. 13/3-2022 PGT-III(1) dated 04.03.2022.

Whereas, Smt. Asha [203987], PGT Pol. Science was charge-sheeted under rule-7 of Haryana Civil Service(Punishment and Appeal)Rules,2016 vide memo No. 13/3-2022 PGT -III (1) Dated 21.07.2022/26.07.2022, wherein the following charges were leveled against her :

- 1. "That on 10.01.2022, you instigated the Health Department team (Sub-Health Centre Kirawad Bhiwani) present in the school premises for "Covid-Vaccination"**

to not get the vaccine (vaccination) and told about its unnecessary side effects. As a result, the team constituted by the Health Department had to send the students back without vaccinating them. Thus, by violating the instructions issued by the Haryana Government regarding vaccination, you created an obstacle in the proper operation of the free vaccination scheme of the Government of India / Haryana Government in public interest for prevention of Corona epidemic.

- 2. On 10.01.2022, you created ruckus by arguing with the vaccination team of the Health Department regarding the vaccine effect of the students (15 to 18 years) by being present in the school premises at PHC Kirawad and instigating the students not to get vaccinated.*
- 3. You are disobeying government orders by creating obstacles in the government-run vaccination campaign by raising unnecessary arguments about the COVID-19 vaccination dose. Despite the government repeatedly providing information about the COVID-19 vaccine in the media, you, i.e., Mrs. Asha, are creating confusion and distrust among students and their parents regarding the COVID-19 vaccine by raising unnecessary arguments about the vaccine. Consequently, a complaint has been registered against you at Police Station Bawani Khera, District Bhiwani, under Sections 186, 34, and 353 of the Indian Penal Code, 1860 (Central Act 45 of 1860) in light of a complaint*

filed by Dr. Puneet, SMO, Tosham, under FIR No. 0012 dated 12.01.2022.

4. *On 10.01.2022, when the team formed by the Health Department arrived at the Sub-Health Center, Kirawad, your arguments and non-cooperation resulted in the students returning without vaccination. That same day, on 10.01.2022, you arrived at the PHC Kirawad campus and created a ruckus at the PHC, obstructing the work of the Health Department and disregarding departmental rules. This incident was also made a major news story in newspapers, tarnishing the department's image.*

Whereas, the charged officer submitted her reply to the said charge sheet on 13.09.2022 and denied all the charges leveled against her. She submitted in her reply that the charges leveled against her are false and baseless and further stated that the mistake has been committed due to ignorance of the rules and the same has not been committed intentionally.

Whereas, she was reinstated vide order dated 21.06.2023 by posting her at GSSS Ratera [0398] Bhiwani and she joined there on 23.06.2023.

Whereas, an Inquiry Officer was appointed on 10.01.2023 to enquire into the matter. The Inquiry Officer submitted enquiry report on 16.03.2023, in which three allegations were found proved and fourth allegation was found partially proved. The inquiry officer came to a conclusion that, because of her heated exchange of words with the team of CHC Kirawar, they left the School and no Vaccination was done in the School. It created a bad publicity for the Government

for which the delinquent is responsible. The delinquent also admits that this happened because of misunderstanding. The incharge of sub center had to call the Police and ultimately a FIR No. 12 dated 12.01.2022 U/s 186, 34 and 353 of IPC was registered against the delinquent in PS Tosham, Bhiwani. Later on the FIR was closed on the statement of incharge of sub center Kirawar. Thus, the charges leveled upon the delinquent were found proved. Thereafter, the charged officer was heard in person by the undersigned on 12.08.2024. During the course of hearing, she reiterated her submissions made in her reply.

Whereas, due to heated exchange of words by the charged officer with the vaccination team, vaccination could not be done in the School & FIR was lodged which was later on withdrawn. The charged officer should not have indulged in such kind of behavior. However, taking a lenient view, the charge-sheet U/r 7 was converted to charge-sheet U/r 8 and a penalty of 'Censure' was imposed on the Charged Officer.

Whereas the following provision has been made in Rule-90 of HCS (General) Rules, 2016 for treatment of suspension period and the same is reproduced here as under:-

Where the competent authority is of the opinion that the Government employee has not been fully exonerated, he shall be given such proportion of pay and allowances as the competent authority may prescribe. The payment of allowances shall be subject to all other conditions under which such allowances are admissible. The period of absence from duty shall not be treated as a period spent on duty unless the competent authority specifically directs that it shall be treated as duty for any specified purpose.

Vinit

Note 1.— If no order is passed to treat the period of absence as duty for any specified purpose, the period of absence shall be treated as 'non-duty'. In such event, the past service (i.e. service rendered before dismissal removal, compulsory retirement or suspension) shall not be forfeited.

Note 2.— Except as per provision in Note 2 below rule 89, in all other cases on reinstatement after suspension, the date of re-instatement shall be the date on which the Government employee assumes charge of his post. For the intervening period from the date of order of re-instatement to date of assumption of charge the Government employee shall also be treated as remained under suspension.

Since Smt. Asha [203987], PGT Pol. Science was not fully exonerated, and punishment was imposed on her under the relevant rules. Therefore, there is no justification to treat the suspension period as duty period and to allow her any pay and allowances beyond subsistence allowance as per Rule-90 of HCS (General) Rules, 2016. Therefore, the claim of the petitioner is hereby rejected.

I order accordingly.
