Whereas, Sh. Jitender Gaur [042098], the then Principal, Government Senior Secondary School, Nindana [2669] Rohtak now Block Education Officer, Kathura [5046] Sonipat was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/42-2021 HRG-I (1) dated 16.08.2023/ 23.08.2023 and the following charges were leveled against him:-

Shri Vijay Kumar Chawla, Advocate, Chamber No. 435, District Court Rohtak made a complaint dated nil against him i.e. Shri Jitender Gaur being principal leveling various allegations of irregularities in construction works at Government Senior Secondary School, Nindana (Rohtak). In this context, Executive Engineer Office of the Haryana School Shiksha Pariyojana Parishad, Haryana, Panchkula was appointed Inquiry Officer vide order dated 03.12.2021/10.12.2021 and the Executive Engineer Haryana School Shiksha Pariyojana Parishad, Haryana, Panchkula submitted report vide letter no. Civil/SS/13093 dated 15.09.2022 which was examined and following irregularities were found to be committed on his part i.e. Shri Jitender Gaur being principal:-

1. That grant of Rupees 19.60 lacs was released vide letter no. 2/21-2018 Works(1) dated 18.05.2018 for repair of boundary wall of Government Senior Secondary School, Nindana (Rohtak) and the following lapses were found to be committed while utilizing the said grant by him i.e. Shri Jitender Gaur:-
 - (i) The quantity of Cement of 50 bags were less purchased than the measured quantity.
 - (ii) Less Bricks were used i.e. 17818 than the measured quantity.
 - (iii) Less sand/dust was used i.e. 930.11 cu.ft which was purchased less than the measured quantity.
 - (iv) No brand/company name on the cement bills of 1200 bags though the brand name and grade is required to be mentioned on the bills because rate differ for grades and brand name.
 - (v) As per Measurement Book labour payment comes out to Rupees 5,39,000/- but as per Muster Roll Rupees 4,11,000/- approx were made in form of labour payment and thus, the work was not as per Public Works Department specification.
 - (vi) Consumption of snow-cem comes out 817 Kilogram but 640 Kilogram which is not as per Public Work Department's specification.
 - (vii) That Material was purchased from M/s Vinod and Azad Friend Enterprises, Gohana, Sonapat which was 35 kilometers away from the school whereas the firms in Block Meham were available at the distance of 10 Kilometers. Further, the rate charged by M/s Vinod & Azad Friend Enterprises, Gohana, Sonapat for

crusher and Bajri does not match with the rates approved by the District Level Committee, Rohtak.

2. That grant of Rupees 4.87 lacs was released vide letter no 2/21-2018 Work(1) dated 24.10.2018 him to Government Senior Secondary School, Nindana , Rohtak for interlocking tiles and the following lapses were found to be committed while utilizing this grant by him i.e. Shri Jitender Gaur:-

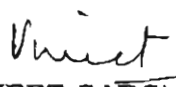
- (i) Quantity of cement of 35 bags was less purchased than the measured quantity and 868 less bricks were used than the measured quantity.
- (ii) Crasher was purchased @1200 ft but as per measurement book only 45 cu.ft was used which is lapse and loss of Rupees 43,890 to State Exchequer.
- (iii) 1404 less Interlocking tiles were purchased @12.50/- but District Level committee has approved the rates as per rate @12.00/-
- (iv) Amount of Rupees 4.87 lacs was approved but Rupees 5,43,528/- was shown to be spent in cash book and thus, the work was not as per Public Work Department specification.

In this way, he i.e. Shri Jitender Gaur performed his duty in a negligent and irresponsible manner and committed an act unbecoming of a Government officer and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016. Thus, he caused a total loss of Rs 1,62,016/- to the State Exchequer.

Thereafter, Sh. Jitender Gaur submitted reply to the said charge-sheet on dated 10.10.2023 and denied all the allegations leveled against him. Thereafter, Shri Parveen Kumar Garg, DGHS (Retd.) was appointed as Inquiry Officer vide order dated 29.12.2023 to hold regular departmental enquiry into the allegations. The Inquiry Officer submitted his report dated 30.01.2024, wherein the charges levelled against the charged officer were found not proved. In the interest of justice, he was granted opportunity of personal hearing on 01.10.2025. The charged officer has deposited the amount of Rs. 162016/- through challan GRN No. 0140497831 dated 02.10.2025 and requested to drop all the charges levelled against him.

In view of the facts of the case, circumstances, taking a lenient view, the charge-sheet against the charged officer is dropped with a warning to be careful in future.

It is ordered accordingly.

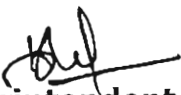

Whereas Evergreen Public Sr. Sec. School, Kaithal was granted permanent recognition for 1th to 12th level vide order no G-1/14/4630-35 dated 21.08.2014 by Deputy Commissioner Cum Chairman, Kaithal.

Whereas Sh.Suresh resident of Jakholi Aadda Kaithal made a complaint against Evergreen Public Sr. Sec. School, Kaithal, wherein it was alleged that two students namely Himansu and Keshav were admitted under the Chirag Scheme and an amount of Rs. 2,000/- was illegally charged from them in the name of government funds along with Rs. 350/- for textbooks. The matter was enquired into by the Block Education Officer, Kaithal, in his report he stated that the school did not cooperate during the enquiry proceedings, refused to refund the wrongly collected amount and the students' SLC's. It has also recommended that action may be taken against the said school as per the rules.

Whereas, Evergreen Public Sr. Sec. School, Kaithal was granted permanent recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.

The Rule 158 (2) of Haryana School Education, 2003 provides that the procedure for collecting fee in a recognized school shall be open, transparent and accountable. The fee shall be collected from students through cheque/DD/RTGS/NEFT/any other digital mode of payment. That the Chirag Scheme (Chief Minister Equal Education Relief, Assistance, and Grant - CHIRAG) has been launched by the Haryana Government with the objective of providing quality education to students from the Economically Weaker Section (EWS). Under this scheme, the state government grants free admission to EWS category students in selected private schools to ensure they receive better educational opportunities.

The said school is demanding fees from students admitted under the Chirag Scheme, despite the policy mandating free education for eligible students. Parents are being pressurized to pay fees in violation of the guidelines. The issuance of School Leaving Certificates (SLCs) is governed by the Haryana School Education Rules, 2003. Specifically, Rule 139(1) stipulates that no recognized school shall admit a student from another recognized school without an SLC. This rule underscores the mandatory nature of the SLC for student transfers in other schools.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution
(2) The recognition/NOC of the school shall lapse if the school,–
(a) XXXX
(b) XXXX
(c) XXXX
(d) XXXX.
(e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why the recognition granted to the school may not be withdrawn Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
