6. In terms of Note 2 below Rule 26 of HCS (Leave) Rules, 2016 the period of extraordinary leave shall not be treated as qualifying service for any purposes.
7. As per note below Rule 72 of HCS (Leave) Rules, 2016 the probation period shall be extended by the period of leave availed during the probation.

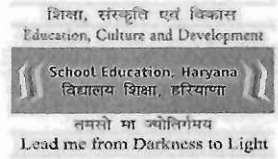
