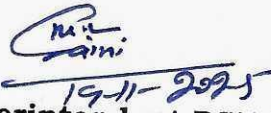

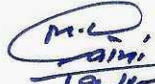

Whereas, Sh. Birbhan has filed the CWP No. 11320 of 2025 titled as Birbhan Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying for issuance of an appropriate writ, order or direction, especially a writ in the nature of mandamus directing the respondents to issue appointment letter and allot station to the petitioner for the post of PGT (Sanskrit) in pursuance of the result dated 07.01.2024 and recommendation made by the respondent No. 3 i.e. Commission in recruitment process arising from Advertisement No. 4/2015, Cat. No.16.

This writ petition came up for hearing on 09.07.2025 and the Hon'ble High Court was pleased to dispose of the above mentioned CWP vide orders dated 09.07.2025. The operative part is as under:-

"....2. Learned State counsel has referred letter dated 28.01.2019, received from University Grant Commission (UGC), to the effect:

"Complaints were received by UGC from individuals across the country against Easter Institute for Integrated Learning in Management (EILM) University (Private University), Jorethang, District-Nimchi, Sikkim about numerous programmes run through distance mode, opening of unauthorized study centre(s), franchising of higher education, issuing degrees to students without conducting any exams or practicals, misleading students by promoting wrong information on website, selling degrees by charging money instead of providing classes or conducting exams, selling degrees in India, conducting programmes through collaborative mode with industries/firms/companies and abroad by conducting courses in one sitting (sitting) and establishment of off-shore campus at Mauritius."

Further, it is germane to mention here that EILM University is already been dissolved by the Government of Sikkim vide their cabinet meeting held on 28th April, 2015. As per UGC's clarification letter it has been specifically clarified that:-

".....Director (Higher Education), Human Resource Development Department, Government of Sikkim may validate the degrees of 2009-10 in three disciplines i.e. B.A. (Hospitality and Tourism), BCA and MBA for students admitted within the territorial jurisdiction of State of Sikkim based on the admission records available with the university's Sikkim campus/State Government. Degrees in other

Disciplines except in three as specified in the preceding lines and beyond academic year 2009-10 shall not be valid."

She contends that the petitioner, undisputedly, obtained degree of MA Sanskrit from the EIILM University, after completing the course from January, 2010 to December, 2011. The degree has not been considered valid in terms of the aforesaid UGC letter. She also contends that the decision taken by the Commission in that regard will be conveyed to the petitioner within four weeks..."

Thereafter, the petitioner filed Civil Miscellaneous Application No. 13584-CWP-2025 in the said writ petition, seeking modification of the aforementioned order and the same was allowed by the Hon'ble High Court on 22.09.2025 with passing following orders:-

"...The application has been filed seeking correction in the order dated 09.07.2025, to the extent following statement by learned State Counsel has been recorded therein:

2..... She also contends that the decision taken by the Commission in that regard will be conveyed to the petitioner within four weeks.

2. Learned counsel for the parties are ad idem that the word 'Commission' has been wrongly typed as the decision is to be taken by the Director, Secondary Education.

3. In view thereof, the application is allowed and it is ordered that last line of paragraph 2 in the order dated 09.07.2025 will now read as under:

2.....She also contends that the decision that the decision taken by the Director, Secondary Education in that regard will be conveyed to the petitioner within four weeks."

In compliance of the order dated 09.07.2025 and the modified order dated 22.09.2025 passed by the Hon'ble High Court, the case of the petitioner has been duly examined. It has been observed that, as per the recommendation received from the Haryana Staff Selection Commission (HSSC), all candidates, including the petitioner, were called for document verification on 18.01.2024. The Document Verification Committee noted that the petitioner obtained his Master's Degree from EIILM University, Sikkim, during the academic session January 2010 to December 2011.

In this regard, the matter concerning EIILM University is already sub-judice before the Hon'ble High Court in CWP No. 1057 of 2019 titled as Vishnu Dutt and others vs. State of Haryana & others, in view of the clarification sought by the Department vide letter dated 04.09.2019

for

regarding the validity of Master's Degrees obtained from EIILM University, Sikkim. In response, the University Grants Commission (UGC) had clarified the matter vide its letter dated 18.10.2019, which is re-produced as under:-

"With reference to your letter No. 6/7-2019 PGT-1(2) dated 04.09.2019 regarding subject cited above. I am directed to inform you that Eastern Institute for Integrated Learning in Management University (EIILM), 8th Mile, Malbasey, Budang, West Sikkim-737121 was established by an Act of State Legislature of Sikkim as a Private University and was empowered to award degrees as specified under Section 22 of the UGC Act through its main campus in regular mode with the approval of Statutory Bodies/Councils, wherever its required.

Eastern Institute for Integrated Learning in management University (EIILM), 8th Mile, Malbasey, Budang, West Sikkim-737121 was not authorized to open study centre/off campus centre beyond and territorial jurisdiction of the state as per the judgment to Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh. The University was not permitted to open its centre (s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC. The UGC has not granted any approval to the University to open off campus/study centre.

Complaints were received by UGC from individuals across the country against Eastern Institute for Integrated Learning in Management (EIILM) University (Private University), jorethang, District-Namchi, Sikkim about numerous programmes run through distance mode, opening of unauthorized study centre (s), franchising of higher education, issuing degrees to students without conducting any exams or practical's, misleading students by promoting wrong information on website, selling degrees by charming money instead of providing classes or conducting exams, selling degrees in India, conducting programmes through collaborative mode with Industries/firms/companies and abroad by conducting courses in one sitting and establishment of off-shore campus at Mauritius.

A Fact Finding Committee was constituted by the UGC to:

Look into the above complaints

To examine whether Eastern Institute for integrated learning in management (EIILM) University (Private university), jorethang. District-Namchi, Sikkim is conducting programmes in accordance with UGC (Establishment of and Maintenance of Standards in Private

Universities) Regulations, 2003 and fulfilling criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies.

To enquire into the adherence by the University to the guidelines of the erstwhile Distance Education Council (DEC), approvals/recognition given by DEC to the University, the policy of territorial Jurisdiction laid down by UGC and DEC, and fulfillment of other quality standards for offering programs in distance mode.

To visit the University and its various offices/premises, inspect such documents as it may consider necessary and take copies thereof, record statement and have discussion with such functionaries and other persons of the University as it may deem fit.

The Fact finding Committee visited the university from 27-29th April, 2015. Since the Vice-Chancellor, Registrar, Controller of Examination and Director of distance Education programmes were absconding (as informed by the State Government officials), the Committee met Dean, one Administrative Staff and two Assistant Professors of management.

The Fact Finding Committee recommended as under:-

The committee recommends dissolution of the EIILM University in accordance with relevant section of EIILM University Act. Director (Higher Education), Human Resource Development Department, Government of Sikkim (present during visit) was also taken on board on this. He intimated that state Government was progressing in this direction and this proposal shall be placed in the forthcoming cabinet meeting. Now, Human Resource Development Department, Government of Sikkim, vide their letter No. 84/DIR(HE)HRDD dated 15.05.2015 have intimated that:-

"The state Government of Sikkim has accorded approval for the dissolution of EIILM University in its cabinet meeting held on 28th April, 2015. As per section 48 of EIILM University Act, 2006, the Government has appointed interim management to conduct the affairs of the university till the completion of the process of dissolution."

Being a unitary university, EIILM did not have any mandate to affiliate any college/ institute. UGC never granted any permission/ approval to EIILM University to establish any off-campus centre(s)/ study centre(s)/ off-shore centre(s).

The State Government may be requested to take steps to protect the interest of unsuspecting students of EIILM University residing in Sikkim who have taken admission on regular basis. On campus students may be accommodated by the State Government in different close by colleges and universities; till completion of their courses.

Director (Higher Education), Human Resource Development Department, Government of Sikkim may validate the degrees of 2009-10 in three disciplines i.e. B.A (Hospitality & Tourism), BCA and MBA for students admitted within the territorial jurisdiction of State of Sikkim based on the admission records available with the university's Sikkim campus/State Government. Degrees in other disciplines except in three as specified in preceding lines and beyond academic year 2009-10 shall not be valid.

A public notice may be issued by UGC for public in general, students and parents in particular indicating dissolution of the EIILM University and advising them not to take admission in EIILM University or any of its off campus centers/study centers, Etc.

UGC may communicate with Ministry of Information and Technology for banning and blocking the site of EIILM University which has been misleading students.

The report of the Fact Finding Committee was considered by the university Grants Commission in its 508th meeting (Items No. 5.01) held on 27.07.2015. The Commission resolved as under:-

"Noted and Approved. The Commission further resolved to issue a Public Notice in this regard and also approach the Ministry of DEITY for banning the Website of EIILM."

Accordingly, a Public Notice was issued on 05.08.2015 (available on UGC website www.ugc.ac.in) cautioning the students not to take admission in EIILM university and/or any of its centres/campuses/ distance education programmes. The State Government of Sikkim has been requested to take necessary action on the recommendation of the UGC Fact Finding Committee vide letter dated 05.08.2015.

The State Government of Sikkim vide its notice dated 30.04.2015 notified that the State Government of Sikkim has approved dissolution of the EIILM University under section 47 of the EIILM university Act, 2006 and that no students should apply for fresh admission in the university for the forth coming academic session 2015-16.

The Joint Director Higher Education/SPIO, Human Resource Development Department, Government of Sikkim vide letter No. 57/DIR/HE/HRDD dated 15.05.2018 has informed that EIILM University, Sikkim was closed down in April 2015 is still not open as of date.

The name of Eastern Institute for Integrated Learning in Management University (EIILM), 8th Mile, Malbasey, Budang, West Sikkim-737121 has been removed from the UGC list of universities.

For any information related to EIILM University, validity of its courses and verification of degrees, you may approach Director (Higher Education), Human Resource Development Department, Government of Sikkim, Gangtok, Sikkim.

In view of the clarification received from the University Grants Commission (UGC) vide letter dated 18.10.2019, it has been categorically stated that only those degrees pertaining to the academic session 2009-10 in three specific disciplines, namely B.A. (Hospitality & Tourism), B.C.A., and M.B.A., which were awarded to students admitted within the territorial jurisdiction of the State of Sikkim and duly reflected in the admission records available with the University's Sikkim Campus/State Government, shall be considered valid. The UGC further clarified that any degrees awarded in disciplines other than the aforesaid three courses, or degrees obtained beyond the academic session 2009-10, shall not be treated as valid qualifications for any purpose, as the same were not conducted in accordance with the norms prescribed by the UGC and outside the territorial jurisdiction of the State of Sikkim. In light of the said clarification, it is observed that the petitioner obtained his Master's Degree from EIILM University, Sikkim, during the academic session January 2010 to December 2011, which clearly falls beyond the period recognized as valid by the UGC. Accordingly, the said qualification cannot be treated as a valid degree for the purpose of employment or consideration for appointment to any post under the State Government.

It is pertinent to mention here that several other candidates, who were similarly situated to the petitioner and whose appointments were also withheld by the Department on similar grounds, had approached the Hon'ble High Court by filing various writ petitions, including CWP No. 1057 of 2019 titled as Vishnu Dutt and others vs. State of Haryana & others, seeking directions for issuance of their appointment orders in different subjects advertised under Advertisement No. 4/2015. The issues raised in the said writ petitions pertain to the validity of degrees obtained from EIILM



University, Sikkim, and the consequential eligibility of such candidates for appointment to the posts in question. The aforesaid writ petitions are presently pending consideration for 09.02.2026 and final adjudication before the Hon'ble High Court. In view of the pendency of these matters, which involve identical questions of fact and law, and to maintain uniformity and consistency in the decision-making process, the Department has considered it appropriate to keep the appointment of the present petitioner on hold till the final outcome of the said writ petitions pending before the Hon'ble High Court. The decision in those cases will have a direct bearing on the present matter, and therefore, further action in respect of the petitioner shall be taken only after the Hon'ble High Court delivers its final judgment in the connected cases.

Keeping in view the facts and circumstances mentioned hereinabove, the documents available on record, and the directions/orders passed by the Hon'ble High Court; the claim raised by Sh. Birbhan is kept on hold until the final adjudication and disposal of the pending litigation before the Hon'ble High Court. The final decision in the petitioner's case shall be taken in accordance with the outcome of the said writ petitions and in conformity with the directions that may be issued by the Hon'ble Court.

I order accordingly.
