To fill up the vacant post of High School Headmaster (ROH cadre) the cases for promotion amongst ESHMs and TGTs from seniority no. 1 to 3100 (as it stood on 01/21.11.2025 in joint seniority list of TGT/ESHM) are invited in pursuance with Haryana State Education School Cadre, (Group B) Service Rules, 2012. In this context, following directions are issued for inviting cases for promotions:-

- 1. Cases of 870 working TGT/ESHM from seniority no. 1 to 3100 as it stood on 01/21.11.2025 provided by O/o Directorate of Elementary Education, Haryana may be sent (as per list attached).
- 2. Cases of retirees may not be sent.
- 3. The officials who wishes to forgo promotion may sent their consent with undertaking through their respective district head.
- 4. Cases of promotions may be sent as per enclosed performa with annexure such as bachelor degree with mark sheet, B.ed Degree, summary sheet, no complaint/enquiry/disciplinary action/crimimal proceedings certificate duly countersigned by District Elementary Education officer concern. Cases without authentication from concern authority will not be entertained.
- 5. Personal files/Service Books may not be sent with the promotion cases as the same will not be entertained.
- 6. Cases of officials working on extension beyond 58 years, on account of state awardee/physical handicap etc, must be sent with order of extension in service and attested certificate of State Award/physical handicap.
- 7. If any official founded to be expired, death certificate may be furnished and MIS profile of such official may be updated with such information.



8. You may also direct the officials, which are being considered for promotion, to keep their MIS profile approved and updated with accurate & precise information.
