Compliance of Hon'ble Supreme Court guidelines regarding the use /Publishing of photographs in Government advertisements.

Sir/Madam.

It is submitted that the Hon'ble Supreme Court of India, in its judgments dated 13th May 2015 in W.P.(c) 13/2003 in case titled as "Common Cause Vs Union of India" and 14th June 2016 in has issued clear directions on the use/ publishing of the photographs of government dignitaries in government advertisements.

## As per the directions:

- The exception carved out in paragraph 23 of the aforesaid judgment dated 13th May, 2015 permitting the publication of the photographs of the President, Prime Minister and Chief Justice of the country, subject to the said authorities themselves deciding the question, is now extended to the Governors and the Chief Ministers of the States.
- ii) In Ileu of the photograph of the Prime Minister, the photograph of the Departmental (Cabinet) Minister/Minister In-charge of the concerned Ministry may be published, if so desired.
- iii) In the States, similarly, the photograph of the Departmental (Cabinet) Minister/Minister In-charge in lieu of the photograph of the Chief Minister may be published, if so desired.

You are therefore requested to kindly ensure that all the Government advertisements released by your department comply with these directions of the Hon'ble Supreme Court, and may also circulate these directions to your sub-offices situated in the state or out of the state.
