Whereas, the District Education Officer, Bhiwani has forwarded a case of Smt. Parmila Devi [060407], Post Graduate Teacher in Fine Arts, PM Shri Government Senior Secondary School, Bhangrola [747], Gurugram for treating of suspension period w.e.f 24.01.2022 to 26.06.2023 as the period spent on duty to the Department for consideration/order.

Whereas, a complaint was filed against Smt. Pramila Devi, Fine Arts, GSSS Jacubpura (Gurugram) on 22.04.2019 wherein the complainant alleged that Smt. Pramila Devi while working as PGT completed M.A. Fine Arts Degree from MDU, Rohtak during the year 2008-10 as a regular student without obtaining any leave. Whereas, it is not possible to pass M.A. Fine Arts without taking leave. He also alleged that Smt. Pramila was present in the school during these days and on the basis of this course she also got promotion in the year 2016 and passed her Art & Craft course under admission no.75 under SC-A category in the year 2001 from Industrial Training Institute, Rohtak whereas she belongs to General Category".

Whereas, Smt. Parmila Devi [060407], PGT Fine Arts, GSSS Jacubpura (Gurugram) now posted at GSSS Bhangrola (Gurugram) was placed under suspension vide order no. 15/27-2019 PGT III(1) dated 29.12.2021 & she was charge sheeted under rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order No. 15/27-2019 PGT-III(1) dated 10.06.2022/17.06.2022, wherein the following charges were levelled against her:-

Untrue

"It is that you, i.e. Mrs. Pramila Devi, did MA Fine Arts (Regular) degree from Maharshi Dayanand University, Rohtak (roll number 1103) during the year 2008-2010 without obtaining explicit approval from the competent authority and without getting leave sanctioned, received salary for the said period from the school, got promotion in the year 2016 on the basis of the said degree and despite belonging to the general category, did Fine Arts course from Vishwakarma Private Industrial Training Institute, Kath Mandi, Rohtak in the year 2001

through fake certificate under reserved category (SCA), thereby committing fraud and violating Haryana Civil Services Rules."

Whereas, Sh. O.P. Langyan, IAS (Retd.) was appointed as Inquiry Officer vide Order No. 15/27-2019 PGT-III (1) dated 28.07.2022/05.08.2022. The inquiry officer submitted his report on 03.10.2022, wherein charges no.1 to 3 were found to be proved and charge no. 4 was not proved against delinquent. The above said findings inquiry report was intimated to the delinquent vide letter dated 13.12.2022. Thereafter, the delinquent submitted her reply to the said charge sheet on 04.07.2022 and denied all the allegations levelled against her. The reply was found unsatisfactory and resultantly, an opportunity of personal hearing was given by the competent authority to the delinquent on 01.06.2023 and the charge sheet under rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 was decided with a recorded warning to ensure that she will remain more careful and diligent towards her duty in future vide order dated 22.12.2023/02.01.2024. Thereafter, Smt. Parmila Devi [060407], PGT Fine Arts thereafter, was re-instated in service vide order no. 15/27-2019 PGT III(1) dated 05.06.2023/24.06.2023.

That it is relevant to mention here that the following provision has been made in Rule-90 of HCS (General) Rules, 2016 for treatment of the suspension period and the same is reproduced here as under:-

"Where the competent authority is of the opinion that the Government employee has not been fully exonerated, he shall be given such proportion of pay and allowances as the competent authority may prescribe. The payment of allowances shall be subject to all other conditions under which such allowances are admissible. The period of absence from duty shall not be treated as a period spent on duty unless the competent authority specifically directs that it shall be treated as duty for any specified purpose".

Whereas, since Smt. Parmila Devi [060407], PGT Fine Arts was not fully exonerated, therefore there is no justification to treat the suspension period from 24.01.2022 to 26.06.2023 as duty period. Resultantly, suspension period from 24.01.2022 to 26.06.2023 of Smt Parmila Devi [060407], Post Graduate Teacher in Fine Arts, PM Shri Government Senior Secondary School, Bhangrola [747], Gurugram is

treated as 'Non Duty Period' and her pay & allowances are restricted to whatever paid during suspension period as provided in Rule 90 of Haryana Civil Services (General) Rules, 2016.

It is ordered accordingly.

Show Cause Notice

Memo no. 5/236-2025 PS (1)

Dated, Panchkula:

Whereas Sunshine Public School, Jind Road, Kaithal was granted NOC upto 12th level vide order no 23/152-98 V-1 (2) dated 24.08.98 by Director Secondary Education, Haryana, Panchkula.

Whereas the school has submitted a case regarding change of the school's name from Sunshine Public School to Shri Chaitanya Techno School vide memo No. 2024-25/2041 dated 22.06.2024. In this regard, vide Directorate's order No. 25/7-2024 PS-1 dated 23.07.2024, Shri Praveen Sagwan, Joint Director, was appointed as the inspecting officer to conduct inspection of the said school. After inspection, the officer reported the following deficiencies:

- 1. All classrooms and laboratories were found to have single doors instead of double doors.***
- 2. The bank guarantee of Rs. 2,25,746/- dated 17.07.2018 was valid up to 17.07.2021 and has not been pledged in favour of the Director, Secondary Education, Haryana.***
- 3. The school did not present the requisite drinking water and sanitation certificates at the time of inspection.***

Whereas the District Education Officer, Kaithal submitted her report vide memo number vide letter No. G1/25/1814 dated 26.08.2025/04.09.2025. In the report it is submitted that the school has not obtained any approval from the Department for the change of name. The institution operating under the name Shri Chaitanya Techno School is not recognized by the Department.

Whereas, a complaint against the school was received through the Hon'ble Education Minister, Haryana, and upon enquiry by the Block Education Officer, Kaithal, it was confirmed that "Shri Chaitanya Techno Public School, Jind Road, Kaithal" has no recognition from the Department.

Whereas, Sunshine Public School, Jind Road, Kaithal was granted permanent recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003.



Whereas Rule 3 provides that no school in the state can function, establish or start classes without the prior approval or permission of the Director and every school established by any individual or association of individuals or firm or society or trust or company, shall follow the norms specified under these rules. It further provides that any act or disobedience on the part of the school managing committee contrary to the provisions of these rules shall make it liable under these rules.

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

- Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution**
- (2) The recognition/NOC of the school shall lapse if the school,-**
- (a) XXXX**
 - (b) XXXX**
 - (c) XXXX**
 - (d) XXXX.**
 - (e) has not complied with one or more of the conditions of recognition, specified in these rules.**

It is clear from the above mentioned facts that the school management has started classes without approval of the department of school education and also has not complied with the instruction issued by the department of school education.

Therefore, a show cause notice is being issued to the school management of the said school as to why action may not be taken against the school management under Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with rules.
