Whereas, the names of the 100 selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Physics** vide recommendation No. RG-15/2024/14657 dated 07.02.2025 against Advt. No. 31/2024. While, recommending the names of the selected candidates, the HPSC, Panchkula had made an observation as under:-

“The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 22.02.2025. After completing the due process, appointment letters were issued to 99 eligible candidates who were appeared before document verification committee vide appointment order dated 04.04.2025 & 07.05.2025 and directed to join within 15 days at allotted station. But, the candidate namely Sh. Sushil Yadav S/o Sh. Hoshiyar Singh bearing Roll No. 2457 has not appeared before the committee for verification of documents. Thereafter, one more opportunity has been granted to him for verification of document on 08.05.2025 vide notice dated 02.05.2025. But, he again failed to appear before document verification committee for verification of document and no any re-presentation has been received from him for willingness for joining to the post of PGT Physics.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidate is not willing to serve as PGT Physics as

he has failed to participate in selection process after giving proper opportunities.

In view of the above, it has been decided to cancel his candidature for the post of PGT Physics. However, before cancellation of his candidature, a final opportunity is granted to him to submit his reply in regard to join as PGT Physics within 15 days (till 26.12.2025) otherwise his candidature will be cancelled.

No. 35/2024. While, recommending the names of the selected candidates, the HPSC, Panchkula had made an observation as under:-

The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 22.02.2025. After completing the due process, appointment letters were issued to 35 eligible candidates who were appeared before document verification committee vide appointment order dated 22.04.2025 & 16.06.2025 and directed to join within 15 days at allotted station. The candidate namely Manisha Yadav D/o Sh. Bhoop Singh Yadav bearing Roll No. 6227 not joined her duties and requested for extension in joining period. 




