"That, as per Rule 30(g) of the Haryana School Education Rules, 2003, every school is required to provide a ramp at the plinth level. During the inspection for recognition of Unison International School, Village Damla, Pinjore-Baddi Highway, District Panchkula, you, being a Member of the Committee, mentioned that the school had a ramp. However, the committee constituted at the headquarters level has submitted a report stating that the school does not have a ramp. Hence, this amounts to sheer negligence on your part."

The charged officer submitted her reply to the aforesaid charges and denied all the allegations levelled against her. She further requested to drop the charge sheet u/r-8. In the interest of justice, delinquent was granted an opportunity of personal hearing to explain her position on 18.11.2025.

Accordingly, after examining the reply of the delinquent and report dated 22.11.2025, it has been found that her earlier report was submitted without malicious intent. So, I am of the considered view to file the present chargesheet with warning to be remain careful in future.
