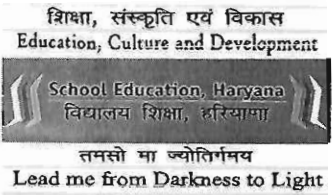

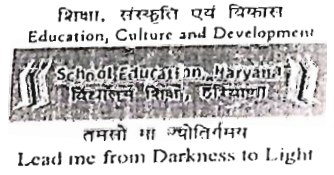

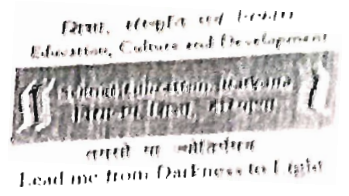

3. यह कि आप अर्थात् श्रीमती मुकेश कुमारी के विरुद्ध आपके पति तथा उनकी माता को मानसिक तथा शारीरिक तौर पर प्रताड़ित करने के आरोप में पुलिस थाना, थानेसर सिटी में भारतीय दण्ड संहिता, 1860 (1860 का केन्द्रीय अधिनियम 45) की धारा 120 बी तथा 306 के अधीन एफ0आई0आर0 संख्या 1333 दिनांक 02.12.2019 दर्ज की गई, जिसके कारण आप दिनांक 27.11.2020 से 14.01.2021 तक न्यायिक हिरासत में रही, जिसकी सूचना आप द्वारा विभाग को नहीं दी गई तथा उक्त एफ0आई0आर0 की प्रति भी उपलब्ध नहीं करवाई, जिसके लिए आप दोषी बनती है।"

श्रीमती मुकेश कुमारी, प्रवक्ता हिन्दी द्वारा उसके विरुद्ध जारी नियम-7 की चार्जशीट का उत्तर दिनांक 20.01.2022 को प्रस्तुत किया गया। जिसके पश्चात् मामले में दिनांक 07.02.2025 को श्री मनोज कुमार बंसल, सेवानिवृत्त मुख्य अभियंता को जांच अधिकारी नियुक्त किया गया। जांच अधिकारी द्वारा मामले की जांच करके, अपनी जांच रिपोर्ट दिनांक 24.04.2025 को प्रस्तुत की गई। जिसमें श्रीमती मुकेश कुमारी, प्रवक्ता

हिन्दी पर लगाए गए आरोप सिद्ध नहीं पाए गए हैं। इसके पश्चात् श्रीमती मुकेश कुमारी, प्रवक्ता हिन्दी को दिनांक 16.07.2025 को निजी सुनवाई का अवसर प्रदान किया गया।

यहां यह भी अंकित करना उचित होगा कि माननीय जिला न्यायालय, कुरुक्षेत्र में दर्ज मामला SC No. 430/2021 में माननीय जिला न्यायालय द्वारा दिनांक 16.08.2024 को अंतिम निर्णय दिया गया था, जिसका पमावशील अंश निम्नानुसार है:-

**“Keeping in view of the totality of the facts and circumstances of the case and in view of the above discussion, it is held that prosecution has miserably failed to bring home the guilt of all the accused namely Mukesh Kumari. Accordingly, extending the benefits of doubts to her, she stands acquitted to the charge under Sections 306 IPC. Her bail bond/surety bonds stand discharged.”**

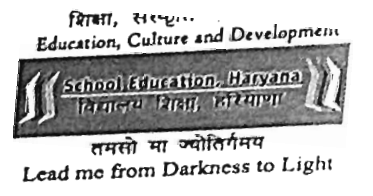

**Dated, Chandigarh, the 10-12-2025**

Whereas, the petitioner had filed CWP No. 9281 of 2025 titled as Suman vs. State of Haryana and others praying for directing the respondents to grant/release all the benefits including arrear to the petitioner as per the clause 11 of the Teacher Transfer Policy, 2016 (amended time to time) (P-1 dated 01.06.2017 & Annexure P-2, Dated 13.04.2022) issued by the Director Elementary Education, Haryana, Panchkula and further directing the respondent to resume the benefit of para 11 of the Teacher Transfer Policy, 2016 (Amended up to date) and not to pressurize the petitioner to deposit the benefit which was earlier been granted to the petitioner.

The aforesaid case came up for hearing before the Hon'ble High Court on 12.05.2025 and the Hon'ble High Court was pleased to dispose of this writ petition with the following directions as under:-

***This petition has been filed, inter alia, seeking a writ of mandamus directing the respondents to grant/release the benefits to the petitioner as per Clause 11 of the Teacher Transfer Policy, 2016 (amended time to time) (Annexures P-1 and P-2, dated 01.06.2017 and 13.04.2022 respectively.***

***2. Learned counsel for the petitioner submits that at this stage, the petitioner will be satisfied in case she is permitted to make a fresh representation before the respondents raising the grievance as has been raised in this petition, and the same may be ordered to be decided within a specified period.***

***3. Notice of motion.***

***4. Ms. Tanushree Gupta, Deputy Advocate General, Haryana, accepts notice on behalf of the respondents/State and submits that in case any such representation is filed by the petitioner within two weeks***

*from today, the same will be decided by respondent no.2/Director General, Secondary Education, by passing a speaking/reasoned order in accordance with law within a period of three months by affording due opportunity of hearing.*

*5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.*

*6. Ordered accordingly.*

*7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioner.*

In compliance of Hon'ble High Court order dated 12.05.2025, the petitioner submitted his representation on 28.08.2025. Accordingly, the matter was examined as per relevant rules/ Govt. instructions/ Policies vide which the services of the petitioner is governed, it has been found that Smt. Suman, PGT Hindi was promoted vide this office order No. 15/19-2022 PGT-I (3)/Hindi dated 31.05.2023 and allotted temporary station at Govt. Sr. Sec. School, Utawar [6481] (Palwal) with the condition to participate in upcoming Teacher Transfer Drive.

As per the Teacher Transfer Policy 2016 amendment issued vide this office Memo. No. KW 8/2-2020 CO-I (2) dated 13.04.2022, there is following provision as under:-

**"if a teacher is willing to be posted in a school located in Morni Educational Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District against a vacancy and who have neither declared Panchkula, Palwal or Nuh respectively as their home district nor have completed class 10th or 12th from school located in Morni Educational Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District respectively, he/she will be paid additional 10% of the Basic Pay + D.A. during the said posting."**

In this matter, the petitioner was posted at Govt. Sr. Sec. School, Utawar [6481] (Palwal) after promotion, not in General Transfer Drive. There is no specific policy w.r.t. online posting after promotion. Thus, the claim of the petitioner is not maintainable as per rules and the claim of the petitioner for additional 10% of the Basic Pay + D.A. is hereby rejected.

Accordingly, in light of relevant Rules and factual position explained above, the prayer of petitioner submitted vide representation dated 28.08.2025 is found to be devoid of merits and, therefore, rejected.
