I am directed to invite your kind attention to Government Instructions No. 16/7/2015-2HR-III dated 23rd October, 2025, whereby the contractual period of Part-II employees engaged against sanctioned posts was extended upto 30.11.2025 (two months).

2. The Government has reconsidered the matter and decided to further extend the contractual engagement of staff appointed under Part-II of the Outsourcing Policy in various Departments, Boards, Corporations, etc., with effect from 01.12.2025 to 31.03.2026 (total 04 months) or until the Security of Service Act, 2024 Portal becomes operational (whichever is earlier) subject to strict compliance with all conditions laid down in HKRNL Memo No. 8018 dated 25.03.2025.
