1. In case the claim belonging to disability certificate of TGT is found false and fabricated at any stage later on, he would be reverted without any notice and without any prejudice to such further disciplinary action as may be initiated under the provisions of the Indian Penal Code for production of such false/fabricated documents.
2. The candidate is directed to provide latest disability certificate in accordance with the Government of Haryana Gazette Notification No. 32/05/2019-6HB-I dated 05.08.2021 within 30 days of joining to promotional post, failing which, he would be reverted without serving upon a notice, if he is still in service.
