Whereas, the petitioner had filed Civil Writ Petition No. 32992 of 2024 titled as Vijay Kumar Vs State of Haryana and others for issuance of a writ in the nature of Mandamus for directing the respondents to step up the pay and pension of the petitioner at par with his junior-respondent No. 4 alongwith all consequential benefits and arrears thereof including interest @ 18% per annum, keeping in view the settled proposition of 'fundamental rule' of stepping up the pay at par with junior laid down by Hon'ble Supreme Court in Union of India vs. Jagdish, 1997(2) SCT 664 SC.

The Hon'ble Punjab and Haryana High Court was pleased to dispose of the aforesaid writ petition vide its order dated 09.12.2024. The operative part of the order is reproduced here as under:-

***"3. Notice of motion.***

***4. Mr. R. S. Budhwar, Addl. A.G., Haryana, accepts notice on behalf of the respondents/State and submits that the pending legal notice, dated 11.09.2024, will be decided by the third respondent/Director, Secondary Education, Haryana, by passing a speaking/reasoned order in accordance with law within a period of six months.***

***5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.***

***6. Ordered accordingly.***

***7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 50,000 to the petitioner."***

In compliance of the aforesaid directions of the Hon'ble High Court, the legal notice of the petitioner Sh. Vijay Kumar, Assistant Director (Retd.) dated 11.09.2024 was examined and after examination, it has been found that the petitioner was initially appointed as clerk in this department by the Director of Public Instruction, Haryana on 06.02.1978. Thereafter, he was further promoted to higher posts as Assistant on 17.10.1988, Deputy Superintendent on 09.09.2005, Superintendent on 20.11.2006, Registrar Education on 27.08.2010, thereafter he was promoted to the post of Assistant Director on 24.06.2011. The petitioner was subsequently retired from services on attaining the age of superannuation on 31.10.2011.

Whereas, at the time of retirement, the salary of the petitioner was fixed at Rs. 23,930/-. However, now, in compliance of Hon'ble High Court order dated 09.12.2024 and concurrence of Finance Department conveyed vide their

ju




U.O. No. 6/44/2021-3PR(FD)/10263 dated 13.10.2025, basic pay of the petitioner has been stepped up and re-fixed as Rs. 24,590/- instead of 23,930/- on account of the benefit of stepping up of his pay at par with his junior i.e. Sh. Jaivir Singh Tewatia (Bansal), Assistant Director (Retd.) w.e.f 17.08.2010 granted to him vide order no. 31/19-1978 dated 10/14.11.2025 .

Therefore, the request for revision of Pension of the petitioner has been sent to Ld. A.G. Haryana vide office Letter No. 10/24-2011 PenI(1) dated 09.12.2025 (Copy attached herewith) and petitioner has also been informed accordingly.

Hence, in view of above facts, the claim of the petitioner has been considered, and the benefit of the step up of pay of the petitioner at par with his junior alongwith all consequential benefits has been granted to him.

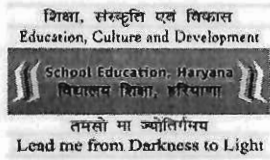
