Whereas, Smt. Meena Verma[036846], Principal, Government Senior Secondary School, Jasrana [3465] Sonapat was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/214-2024 HRG-I (1) dated 15.05.2025 and the following charges were leveled against her

That the Deputy Director Office of the Director Secondary Education, Panchkula was appointed as Inquiry Officer vide order No. 16/16-2024 PGT-IV(1) dated 29.07.2024 in respect of the complaint dated 23.04.2023 made by Shri Yogesh Kumar, Post Graduate Teacher in Hindi and other staff against her i.e. Smt Meena Verma [036846], Principal, Shri Satish Kumar and Shri Haipal. In this regard, report dated 27.09.2024 was submitted by the Deputy Director-cum-Inquiry Officer wherein the following irregularities were found to be committed by her i.e. Smt Meena Verma:-

1. That the Deputy Director Office of the Director Secondary Education, Panchkula visited the school i.e. Government Senior Secondary School, Jasrana [3465], Sonapat on 26.09.2024 at 8.30 AM and found that she i.e. Smt Meena Verma mentioned the time of arrival in the school on 25.09.2024 at 7.50 AM but time of departure was not mentioned in the Attendance Register. Further, she i.e. Smt Meena Verma was not present in the school at 9.30 AM on 26.09.2024 and came to the school on 11.30 AM after telephonic message and it was intimated that she i.e. Smt Meena Verma was on leave on 26.09.2024 for which she has already given telephonic message/information to the Block Education Officer, Gohana Sonapat but from the call record of Shri Satish Kumar, Post Graduate Teacher in Hindi it was ascertained that the said formality of leave was done only after inspection. Thus, she i.e. Smt Meena Verma has violated the provisions of rule 11(2) of the Haryana Civil Services (Leave) Rules, 2016, as she i.e. Smt Meena Verma proceeded on leave without obtaining any prior permission of the competent authority.
2. That the cash book of Mid-Day-Meal Scheme was written upto June,2024 but she i.e. Smt Meena Verma failed to sign on the cash Book and the expenditure on Mid-Day-Meal was made after transferring the funds in Children Welfare Funds which is a serious lapse on her part. Further, cash book of Children Welfare Fund was not written from July,2024 onwards

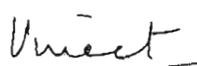
In this way, she i.e. Smt Meena Verma performed her duty in a negligent and irresponsible manner and misrepresented the facts to gain undue advantage and thus committed an act unbecoming of a Government officer and as such, she i.e. Smt. MeenaVerma violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016 and rule 11(2) of the Haryana Civil Services (Leave) Rules, 2016.

Director

Thereafter, Smt. Meena Verma submitted reply to the said charge-sheet on dated 21.05.2025 and denied all the allegations leveled against her. Thereafter, Shri P.K. Goel, Chief Engineer (Retd.) was appointed as Inquiry Officer vide order dated 13.06.2025/ 20.06.2025 to hold regular departmental enquiry into the allegations. The Inquiry Officer submitted his report dated 04.08.2025, wherein the charge No. 2 levelled against the charged officer was found proved. In the interest of justice, Smt. Meena Verma was granted opportunity of personal hearing on 17.12.2025. On the date of hearing, she was heard and she stated that the instructions of the Government dated 05.12.2025 indicated that MDM funds should be deposited in common/ DDO account & the directorate itself transferred MDM funds in CCW A/c. Further she has stated that it is difficult to update cashbook daily as bills are collected from Gohana once in a month or so. There is no complaint of financial embezzlement.

In view of the facts and circumstances of the case, taking a lenient view, the charge-sheet against the charged officer is dropped & the charged officer is warned to be careful in future.

It is ordered accordingly.

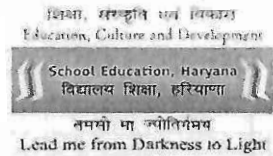

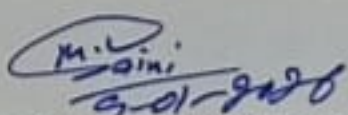
