

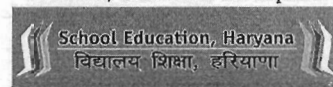



Whereas, your name i.e. Sh. Sandeep S/o Satbir Singh bearing Roll No. 8498 has been recommended by Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Political Science** vide recommendation No. RG-15/2024/2898 dated 25.07.2025 against Advt. No. 32/2024. While, recommended your name, the HPSC, Panchkula made observation as under:-

"The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission."

Accordingly, Document Verification Committees were constituted to verify the documents and you were called for verification of documents on 07.08.2025 alongwith other candidates. But, you remained absent for document verification and intimated over telephone that you are already serving as PGT Political Science at Saheed Sukhbir Singh Govt. Sr. Sec. School, Rukhi (Sonepat) [3592] against Advt. No. 32/2023. Thereafter, you were issued a show cause notice dated 30.09.2025 and directed to submit your reply within 15 days as to why your candidature be not cancelled. But, you have not submitted any reply in response of show notice served upon you.

Keeping in view of the above, you are already serving as PGT Political Science at Saheed Sukhbir Singh Govt. Sr. Sec. School, Rukhi (Sonepat) [3592] against Advt. No. 32/2023. Therefore, I have come to the conclusion that you are not willing to serve as Post Graduate Teacher Political Science (ROH Cadre) against Advt. No. 32/2024. Hence, the

notice dated 30.09.2025 has been confirmed and your candidature for the post of Post Graduate Teacher Political Science (ROH Cadre) is hereby cancelled.
