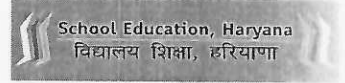

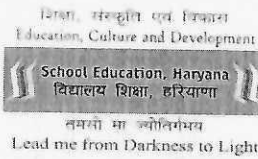

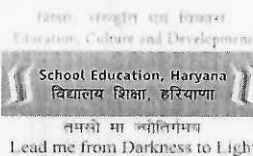

Whereas, CBC Memorial School, Barwala, District Hisar was granted permanent recognition for Classes IX to X vide Order No. 26/92-07 PS(4) dated 28.03.2008 by the Director, Secondary Education, Haryana, Panchkula, subject to the condition that the school shall strictly comply with the provisions of the Haryana School Education Act, 1995, the Haryana School Education Rules, 2003, and instructions issued by the competent authority from time to time.

Complaint from Sh. Sudhir Noor & others has been received against CBC Memorial School, Barwala, Hisar, on the allegations that the school charged fees from the students admitted under the CHEERAG Scheme which is in violation of the scheme guidelines. It was also alleged that the school management refused to issue School Leaving Certificates (SLCs) to the concerned students and used caste-base abusive language against the complainants.

Whereas, the District Education Officer, Hisar submitted a report to the Directorate vide Letter No. G-I/2024/901 dated 13.05.2024, stating that the school was directed by the Block Education Officer, Barwala on 06.05.2024, 07.05.2024 and 08.05.2024 to appear before him/her with relevant records; however, the Principal or Management concerned neither appeared nor produced the requisite records, and the DEO Hisar recommended to withdraw the recognition of the school.

Rule 3 of the Haryana School Education Rules, 2003 mandates that every school shall strictly follow the norms prescribed under the Rules, and any act of omission or commission in contravention thereof renders the school liable for action. Rule 3(1) reads as under:

*Rule 3:- (1) No school in the State can function, establish or start classes without the prior approval or permission of the Director. Every school established by any individual or association of individuals or firm or society or trust or company, **shall follow the norms specified under***

these rules. Any act or disobedience on the part of the school managing committee contrary to the provisions of these rules shall make it liable.

Whereas, under Rule 158(2) of the Haryana School Education Rules, 2003, fee collection in a recognized school shall be open, transparent and accountable, and shall be through digital/traceable modes. Further, the CHEERAG Scheme (Chief Minister Equal Education Relief, Assistance and Grant) envisages free education to eligible EWS category students in empanelled private schools. Any demand/collection of fee from CHEERAG students and denial of SLCs is a serious violation of the scheme obligations and statutory provisions.

Rule 43 of HSER, 2003 provides for withdrawal of recognition for malpractices including non-cooperation, moral turpitude, and obstruction of lawful inspections. The Rule 43 of the HSER, 2003 is reproduced here as under:-

Rule 43:- (1) *The appropriate authority may withdraw/ suspend the recognition/NOC* of a school after giving a reasonable opportunity against the proposed action to be taken against the school in the following circumstances: -*

- (b) *if a school is found involved in malpractices such as mass copying in public examination conducted by any Board or bogus enrolment or tempering of records or **non-cooperation to appropriate authority or moral turpitude** etc.** its recognition/NOC* shall be withdrawn without any notice and the concerned Board shall be intimated (be asked to withdraw its affiliation);*
- (c) *if the managing committee of the school obtains recognition/NOC* by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC* **fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity** and one month notice to show cause against proposed action can withdraw recognition/NOC*;*

Whereas, under Rule 187 of HSER, 2003, the Director is empowered to authorize inspection of recognized schools. Accordingly, a Headquarters-level committee inspected the school on 08.10.2025. During inspection, the management failed to produce CHEERAG-related records and sought time. Despite repeated opportunities, the records were not furnished up to 28.10.2025.

Whereas, an another committee constituted vide order dated 28.10.2025 visited the school for inspection of record on 30.10.2025 with prior intimation to the management concerned, however, on the day of inspection, the management refused to produce the record of CHEERAG students and also asserted that earlier departmental observations were "null and void". The committee reported that the management's conduct was non-cooperative and obstructive. The Chairman of the school management, namely Sh. Virender Singh, also allegedly harassed and threatened the committee members during the verification process and stated that he would lodge an FIR against the committee members including undersigned. The committee submitted videographic evidence of the incident to the undersigned.

Whereas, during the inspection, the committee met the parents of students admitted under the CHEERAG Scheme, who stated that they had been demanding SLCs for a long period and were allegedly subjected to mental and financial harassment. The committee recorded written complaints/affidavits from parents and verified the allegations with available MIS data and reimbursement records.

Whereas, the affidavits/statements submitted by the parents against CBC Memorial School, Barwala, alleging irregularities including denial of SLCs, unauthorised demands of money, continuation of attendance on the MIS portal and wrongful claiming of reimbursement under the Chirag Yojana, are summarised as under::

Whereas, departmental verification further revealed that the school failed to release SLCs for approximately 465 students for sessions 2021-22 to 2025-26 despite repeated directions, and that MIS entries reflected manipulation. It was further observed that certain students were reflected as continuously enrolled on the MIS portal despite not studying for the full academic session, and reimbursement was claimed. The Haryana State Commission for Protection of Child Rights vide Memo No. 2093/HSCPCR dated 16.10.2025 has also recommended departmental proceedings against the school.

Whereas, on examination of the MIS admission records of CBC Memorial School, Barwala, District Hisar, it has been observed that several students, including Sumit (SRN-1510525285) admitted in Class 9th in the academic session 2023-24, Vishnu (SRN-1403682116) admitted in Class 10th in the academic session 2023-24 and like this many more students, were shown as "Repetition/Failed" in the same class on the MIS portal; however, despite such status, these students were again readmitted in the same class in subsequent academic sessions and reimbursement was claimed and received for more than one academic session, including the Academic Session 2024-25. It has further been noticed that the release of such students was shown only on 07.11.2025 by citing "Closure of School", i.e., after the closure of the school MIS portal. In addition, it has also been observed that several students were locked in the originally admitted class on the MIS portal, yet reimbursement for two consecutive years was claimed through manipulated entries even though the students did not study for the complete academic year. The aforesaid acts clearly establish manipulation of MIS data and wrongful availing the Government funds, rendering the school management liable for recovery of excess reimbursement and further action as per the applicable rules.

Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution

(2) The recognition/NOC of the school shall lapse if the school,--

(a) XXXX

(b) XXXX

(c) XXXX

(d) XXXX.

(e) has not complied with one or more of the conditions of recognition, specified in these rules.

Whereas, a Show Cause Notice was issued to the school vide Memo No. 6/122-2024 PS (4) dated 08.05.2025 and a reply dated 09.05.2025 was received and on examination, the reply was found vague, evasive and unsatisfactory, and it did not address the serious allegations relating to fee collection under CHEERAG, non-issuance of SLCs, and non-production of records despite repeated written directions. No verifiable documentary evidence was produced to rebut the allegations or justify non-compliance.


Whereas, from the material available on record, including the report of the District Education Officer, committee inspection reports, parents' affidavits/complaints, verification of MIS data and videographic evidence, it stands established that the school failed to comply with lawful directions for production of records, deliberately obstructed departmental inspections, and did not furnish mandatory records, which constitutes a clear violation of Rule 43 of the Haryana School Education Rules, 2003. By such acts, the school has conducted itself in a manner prejudicial to the educational interests of children, including denial of School Leaving Certificates (SLCs). It is also established that the school misused the MIS portal, leading to wrongful claiming of Government reimbursement, which is clear violation of Rule 3, Rule 43 & Rule 158 of the Haryana School Education Rules, 2003.

In view of the aforesaid facts and material available on record, in exercise of the powers conferred under Rule 42 of the Haryana School Education Rules, 2003, the undersigned, being the competent authority, is of the considered view that the recognition of CBC Memorial School, Barwala, District Hisar, is liable

for withdrawal with effect from next academic session and no further admissions shall be allowed in the said school with immediate effect.


