



Smt. Anju, [093103], Clerk, Government Girls Middle School, Dharamshala Umra [1366], District Hansi is hereby appointed on transfer basis as Clerk in the O/o Director General Secondary Education Haryana, Panchkula. She shall be placed in schedule-I, Pay Matrix of Haryana Civil Services (Pay) Rules, 2016 in FPL-3 (Rs. 21700- 69100) as amended from time to time with the usual allowances admissible to Govt. Servants as per instructions issued from time to time.

Her appointment in the O/o Director Secondary Education Haryana, Panchkula will be on the following terms and conditions:-

1. Her appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which she could continue to officiate in the Directorate of School Education Haryana, she will be repatriated to his parent office. It is, thus made clear to her that at present she has been offered temporary post.
2. She will be required to take the prescribed oath of allegiance to the Constitution of India.
3. In case she is unmarried, she shall have to furnish a declaration to the effect that she will not have more than one living spouse.
4. She will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the prosecution of higher studies.
5. If, she has not been vaccinated within last twelve months she should have done it before reporting herself for duty.
6. In case at any stage, while she remains in temporary capacity desires to resign her post in the O/o Director Secondary Education, Haryana, Panchkula, she will be required to give one month's notice or forfeit in lieu thereof salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to her by the Department also in case it is proposed to terminate her services for reasons other than those mentioned in para-I above. The Department will also be liable to pay salary including allowances for one month or for the period by which the notice falls short of one month. In case of misconduct, however, she will be entitled to a reasonable opportunity to show cause notice as to why her services should not be terminated, in that case the condition of one month's notice shall not apply. Her services will be governed by the Haryana Education Directorate (State Service Class-III), Rules 1974, Haryana Civil Services (P&A) Rules 2016 and Employees Conduct Rules 2016 as amended from time to time etc.
7. She will be on probation for a period of one year from the date of joining. If her work and conduct is not found satisfactory, she will be repatriated to her parent cadre without giving any notice to her.

8. In case she is married, she would have only one living spouse, if she has more than one living spouse, she should justify for that.
9. She will be given seniority as per Rule 11 of the Haryana Education Directorate (State Service Class-III), Rules 1974 as amended from time to time. She will be assigned seniority from the date she joins in the Head Office and will be placed at the tale-end of the employees already appointed in the Head Office.
10. She will have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) if not qualified earlier. She will not be entitled to earn any increment in her pay scale till she qualifies the said test failing which the service of such employee shall be dispensed with.
11. Her services will be governed under the New Pension Scheme of the Haryana, Government.
12. No T.A/D.A. will be allowed to her for joining this post.

If she is willing to accept the offer made on the above mentioned conditions, she may get herself relieved and report for duty to the O/o Director General Secondary Education Haryana, Panchkula within a period of 15 days from the date of issue of this letter.

Whereas, the names of the 16 (Rest of Haryana Cadre) selected candidates have been recommended by the Haryana Staff Selection Commission, Panchkula for appointment to the post of PGT **Sanskrit** vide recommendation no. HSSC/Conf./Recomm./01/48/2025/CA-11/346 dated 14.11.2025 against Advt. No. 04/2015, Category No.16. While, recommending the name of the selected candidate, the Haryana Staff Selection Commission, Panchkula had made an observation as under:-

***“The selected candidates have not been medically examined and no special inquiry into their antecedent has been made. The documents pertaining to their Essential Qualifications, Age, Caste/Category, Universities and Experience are claimed /attached by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duty. A copy of the appointment letter issued to the candidate may also be endorsed to the Commission”***

Accordingly, Document Verification Committee was constituted to verify the documents and all the recommended candidates were called for verification of their documents on 27.11.2025, but the following 02 candidates remained absent during the verification of documents:-

Thereafter, opportunity on website was again given for verification of documents by the department on 31.12.2025, but these candidates again failed to appear before document verification committee and no request has been received from them regarding consideration for appointment till date.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidates are not willing to serve as PGT Sanskrit as they have failed to appear before Document Verification Committee for verification of their documents despite giving appropriate opportunities.

In view of the above, it has been decided to cancel their candidature for the post of PGT Sanskrit. However, before cancellation of their candidature, a notice is hereby served upon them, as to why their

candidature be not cancelled. Reply, if any, they want to file in response to this notice may be filed in the office of Director General Secondary Education, Haryana, Panchkula and through E-mail i.e. [dsepgt1@gmail.com](mailto:dsepgt1@gmail.com) not later than 15 days from the date of this notice. In case, they fail to respond to the notice within a stipulated period, it shall be presumed that they have nothing to say/submit in this regard and their candidature will be cancelled.


