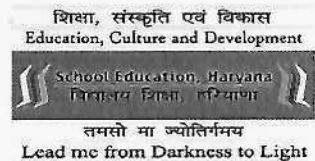

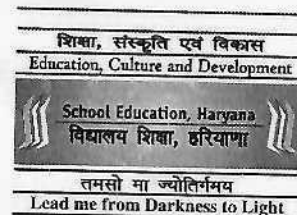

Whereas, name of Smt. Sumit D/o Suresh Chander bearing Roll No. 1238 has been recommended by Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Political Science (Mewat Cadre)** vide recommendation No. RG-36/2022/9396 dated 07.12.2023 against Advt. No. 48/2023. While, recommending name, the HPSC, Panchkula made observation as under:-

"The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission."

Accordingly, Document Verification Committees were constituted to verify the documents and Smt. Sumit was called for verification of documents on 23.12.2023 along with other candidates. But, she remained absent for document verification. Thereafter, opportunities were granted for document verification on 29.06.2024 and 08.05.2025. But, Smt. Sumit again remained absent and intimated over telephone that you are already serving as PGT Political Science at Government Senior Secondary School, Mundia Khara (Mahendergarh) [3971] against Advt. No. 32/2023 in Rest of Haryana Cadre, therefore, she is not willing to join as PGT Political Science for Mewat Cadre against Advt. 48/2023.

Keeping in view of the fact that, Smt. Sumit is already serving as PGT Political Science at Government Senior Secondary School, Mundia Khara (Mahendergarh) [3971] against Advt. No. 32/2023, I have come to the conclusion that she is not willing to serve as Post Graduate Teacher Political Science (Mewat Cadre) against Advt. No. 48/2023. Hence,

candidature of Smt. Sumit for the post of Post Graduate
Science (Mewat Cadre) against Advt. No. 48/2023 is hereby cancelled.

I order accordingly.
