Whereas, St. Xavier Senior Secondary School, Near Railway Station, Sirsa was granted NOC for classes 1st to 12th vide order no. 12/34-2007 PS (3) dated 18.02.2008 by the Director Secondary Education, Haryana, Panchkula.

Whereas a complaint was received from Sorabh Mehta against the St. Xavier Senior Secondary School, Near Railway Station, Sirsa alleging that the school has prescribed private publisher books in the school. Whereas the District Education Officer, Sirsa submitted her report. In the report it was submitted that the school management is using the books of private publishers instead of NCERT books in school.

Whereas the Director Secondary Education Haryana vide its memo no. 8/27-2020 PS (2) dated 06-05-2021 has issued directions for prescribing only NCERT Books in all private recognized schools in the state of Haryana.

Whereas the said school has violated the above mentioned statutory rules by prescribing books other than NCERT/ Private publishers books.

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution
(2) The recognition/NOC of the school shall lapse if the school,-

(e) has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why action may not be taken against the school management under Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 30 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and an appropriate order shall be passed in accordance with Rules.
