Whereas the said school has violated the above mentioned statutory rules by prescribing books other than NCERT/ Private publishers books.

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

**Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution**

Whereas, Smt. Saroj Devi [048959] Principal, GMSSSS Raipur Rani [3708] Panchkula was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/200-2024 HRG-I(1)/1 dated 26.09.2025/03.10.2025 and the following charges were leveled against him:-

"That a committee under the chairmanship of Smt. Sunita Ruhil, Joint Director (Academic), office of the Director General Elementary Education was constituted for conducting fact finding enquiry to figure out the excess purchase of Dual Desk for Classes 1st to 5th and 6th to 8th. The aforesaid committee submitted report dated 24.01.2024 and the following irregularities were found to be committed by her i.e. Smt. Saroj Devi being principal:-

The office of Director Secondary Education, Panchkula issued detailed guidelines vide No. 4/4-2022 AF(1) dated 30.09.2022 for the process of purchase of Dual Desk and she i.e. Smt. Saroj Devi being the Principal made demand of 100 Dual Desk for classes 6th to 8th, but lateron she i.e. Smt. Saroj Devi purchased 110 Dual Desk. In this way, she i.e. Smt. Saroj Devi purchased 10 Dual Desk in excess to the demand which resulted in enhancement of budget allocation for the aforesaid pilot project and loss to the State Exchequer.

In this way, she i.e. Smt. Saroj Devi performed her duty in a negligent and irresponsible manner and committed an act unbecoming of a Government officer and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016."

Thereafter, Smt. Saroj Devi submitted reply to the said charge-sheet on dated 15.10.2025 and denied all the allegations levelled against her, she stated that on 17.08.2022 the demand of 110 dual desk was made through online google sheet, no additional demand of dual desk was made on 06.09.2022. Thereafter, in the interest of justice, she was given personal hearing on 17.12.2025.

On perusal of reply submitted by the charged officer, relevant file, it is found that, the charged officer has submitted the demand of 110 dual desk through online google sheet on 17.08.2022. Therefore, she cannot be held responsible for the charges levelled in the charge sheet and the same deserve to be filed.

It is ordered accordingly.
