Terms & Conditions:-

- The benefit of notional pay fixation and seniority will be admissible w.e.f. 13.06.2025 from the date when his/her juniors have been promoted and actual financial benefits will be admissible to her from the date when he/she joins duty as **PGT English**.
- He is posted temporarily in the school with the condition that he/she must he/she must participate in the next phase of transfer drive for permanent posting.
- If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending. Subsequently, the said incumbent (s) shall be reverted without issuing any notice.
- The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
