संख्या 05/10/2020-5एफ.आर./21737.— भारत के संविधान के अनुच्छेद 309 के परन्तुक के अधीन प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. (1) ये नियम हरियाणा सिविल सेवा (यात्रा भत्ता) संशोधन नियम, 2026 कहे जा सकते हैं।
(2) ये 24 नवम्बर, 2021 से लागू हुए समझे जाएंगे।
2. हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 में, नियम 2 में,—
 - (1) अन्त में विद्यमान "।" चिह्न के स्थान पर, "।" चिह्न प्रतिस्थापित किया जाएगा; तथा
 - (11) निम्नलिखित, परन्तुक रखा जाएगा, अर्थात्:—

"परन्तु हरियाणा राज्य के मामलों के संबंध में सेवारत अखिल भारतीय सेवाओं के सदस्य, हरियाणा सरकार में पदग्रहण करते समय या भारत सरकार या किसी अन्य राज्य सरकार/संगठन से प्रतिनियुक्ति से वापस लौटने के समय अथवा राज्य सरकार द्वारा दरों में पुनरीक्षण के समय, यदि कोई हो, या तो अखिल भारतीय सेवा (यात्रा भत्ता) नियम, 1954 या हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 को चुनने के लिए एक "विकल्प" का प्रयोग कर सकते हैं। ऐसा विकल्प तीन मास की अवधि (उक्त घटना के घटित होने की तिथि से आरम्भ होने वाली) के भीतर प्रस्तुत किया जाएगा अन्यथा यह माना जाएगा कि वह हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 का विकल्प चुनना चाहता है। हरियाणा राज्य के मामलों के संबंध में सेवारत अखिल भारतीय सेवाओं के वर्तमान सेवारत सदस्य, जिन्होंने अभी तक अपेक्षित विकल्प का प्रयोग नहीं किया है, राजपत्र में इन नियमों के प्रकाशन की तिथि से तीन मास के भीतर लिखित में उक्त विकल्प प्रस्तुत कर सकते हैं।"

No. 05/10/2020-5FR/21737.— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Travelling Allowance) Rules, 2016, namely:-

1. (1) These rules may be called the Haryana Civil Services (Travelling Allowance) Amendment Rules, 2026.
- (2) They shall be deemed to have come into force from the 24th November, 2021.
2. In the Haryana Civil Services (Travelling Allowance) Rules, 2016, in rule 2,
 - (i) for the sign “.” existing at the end, the sign “:” shall be substituted; and
 - (ii) the following proviso shall be inserted, namely:-

“Provided that members of All India Services serving in connection with the affairs of Haryana State may exercise an “option” at the time of joining in Haryana Government or returning back from deputation from Government of India or any other State Government/ Organization or also at the time of revision of rates by State Government, if any, either to opt the All India Services (Travelling Allowance) Rules, 1954 or Haryana Civil Services (Travelling Allowance) Rules, 2016. Such option shall be submitted within a period of three months (starting from the date of occurrence the said event) otherwise it shall be assumed that he wants to opt Haryana Civil Services (Travelling Allowance) Rules, 2016. Existing serving members of All India Services serving in connection with the affairs of Haryana State, who have not yet exercised the requisite option may submit the said option in writing within three months from the date of publication of these rules in the Official Gazette.”
