

संख्या 04/17/2025-4एफ.आर./26704.— भारत के संविधान के अनुच्छेद 309 के परन्तुक के अधीन द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (सामान्य) नियम, 2016 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:-

- (1) ये नियम हरियाणा सिविल सेवा (सामान्य) संशोधन नियम, 2026 कहा जा सकते हैं।
(2) ये नियम राजपत्र में इनके प्रकाशन की तिथि से लागू होंगे।
- हरियाणा सिविल सेवा (सामान्य) नियम, 2016 में, नियम 8 में, खण्ड (2) के स्थान पर, निम्नलिखित खण्ड प्रतिस्थापित किया जाएगा, अर्थात्:-
“(2) “प्रशासनिक सचिव” से अभिप्राय है, कोई अधिकारी, जो आयुक्त एवं सचिव, हरियाणा सरकार की पदवी से नीचे का न हो।
टिप्पण.— प्रशासनिक सचिवों की हैसियत में सम्बन्धित आयुक्त और सचिवों द्वारा दिनांक 16 अप्रैल, 2023 से लिए गए सभी निर्णय, इसके द्वारा, निरस्त किए जाते हैं।”।

No. 04/17/2025-4FR/26704.— In exercise of the powers conferred under the proviso to Article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend Haryana Civil Services (General) Rules, 2016 namely:-

1. (1) These rules may be called the Haryana Civil Services (General) Amendment Rules, 2026.
(2) They shall come into force from the date of their publication in the Official Gazette.
2. In the Haryana Civil Services (General) Rules 2016, in rule 8, for sub-rule (2), the following sub-rule shall be substituted, namely:-

“(2) “administrative secretary” means an officer not below the rank of the Commissioner and Secretary to Government, Haryana;”

Note.- All decision taken by the concerned Commissioner and Secretaries in the capacity of Administrative Secretaries from the 16th April, 2023 onwards are hereby regularized;”.
