No. 7/1-2025 Co(2)- In exercise of the powers conferred by Article 162 and 166 of the Constitution of India, the Governor of Haryana hereby makes the amendments in Clause 3(xiv), (xxiii)d, 5(i)d & inserts Clause 6(xii) in Teacher Transfer Policy, 2025 as follows:

Clause No.	Existing Clause	Amended Clause
3(xiv)	<p>'Prescribed Tenure': The tenure of 5 years (calculated continuously or cumulatively) at a particular unit (on any core post in School) or tenure of 15 years (calculated continuously or cumulatively) in a particular block (on any core posts) after which a Teacher has to mandatorily participate in transfer drive. While calculating the prescribed tenure of a teacher in a unit and/or in a Block, as on the qualifying date, the following shall be taken into account:</p> <ol style="list-style-type: none"> a. Duty period spent in a unit; b. Period of training/deputation, provided posting is made in the same unit where posted before proceeding on training/deputation; c. Period of suspension, if the headquarter is not changed for suspension period and posted on reinstatement within the same unit where the posting was before suspension; d.
