Terms and conditions:-

1. The provisionally appointment order is offered subject to the final outcome of SLP No. 3263 of 2023 – Tarsem Sharma and others V/s State of Haryana & others and other connected SLPs pending for adjudication in the Hon'ble Supreme Court of India.
2. The appointment order is hereby offered provisionally and inter-merit will be determined as per the direction of Hon'ble Supreme Court.
3. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation

against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.

4. The candidate shall have to take an oath of allegiance to the Constitution of India.
5. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.

Whereas, Smt. Ragini Sharma [011404], the then Principal, Government Senior Secondary School, Naggal [161] Ambala now ret'd. was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/127-2023 HRG-I (1) dated 03.02.2025 and the following allegations were levelled :-

That Shri Deepak Kohli, 19, Durga Nagar, Hisar Road, Ambala City has made complaint dated 18.07.2023 wherein allegations of financial irregularities were leveled against her i.e. Smt. Ragini Sharma. In this context, District Education Officer, Ambala was directed vide letter no. 5/127-2023 HRG-I(1) dated 10.08.2023 to enquire the matter and report was submitted vide letter no. E-1/10/2023/5935 dated 25.10.2023 and the following irregularities were found to be committed by her i.e. Smt Ragini Sharma being principal:-

1. That Grant amounting to ₹14,67,000/- was released vide letter no. 2/85-2019 W(1) dated 17.07.2019 to Government Senior Secondary School, Naggal, District Ambala for construction of boundary wall in the year 2019-20 but she i.e. Smt Ragini Sharma failed to submit the estimate for such construction work. Further, she i.e. Smt Ragini Sharma failed to provide the copy of order whereby Shri Gurvinder Singh Gill, Post Graduate Teacher English, Shri Sahiram, Post Graduate Teacher Sanskrit and Smt Pooja, Post Graduate Teacher Biology were made members of purchase committee. In addition to this, raw material for construction was purchased from the open market without and the quotations were found undated and no comparative statements were prepared. Further, the Junior Engineer has assessed the difference between the material procured and quantity used for the aforesaid construction work which is as under:-

Misc In this way, recovery of ₹167770/- is to be recovered from her i.e. Smt Ragini Sharma being principal for utilization of less raw material in comparison to the bills of raw material.

2. That she i.e. Smt Ragini Sharma being principal committed financial irregularities in maintenance of musteroll for the month of November 2019 which is as under:-

That she i.e. Smt Ragini Sharma being principal made payment of ₹14208/- to Shri Naveen Kumar S/o Shri Sohan Lal, Village Sagti, Ambala from 08.12.2019 to 31.12.2019 though the other laborer were paid for the period from 14.12.2019 to 31.12.2019. In this way, additional payment of ₹3552/- has made to Shri Naveen Kumar S/o Shri Sohan Lal, Village Sagti @592/- which is to be recovered from her i.e. Smt Ragini Sharma. Further, an amount of ₹8982/- was paid in excess by her i.e. Shri Ragini Sharma being principal to the laborers for the month of November 2019.


3. That resolution was passed in meeting held by Additional Deputy Commissioner, Ambala on 30.03.2021 to condemn six rooms and two joint toilets of Government Senior Secondary School, Naggal, District Ambala and auction was held on 07.04.2022 but the number of rooms are not mentioned in the auction register and thus, it cannot be assessed that how many rooms were dismantled by the principal i.e Smt Ragini Sharma which is lapse on her part.

In this way, she i.e. Smt Ragini Sharma performed her duty in a negligent and irresponsible manner and committed an act unbecoming of a Government officer and violated the provisions of Haryana Voluntary State Education Service Rules and also the rule 4(1) and (2) of the Haryana Civil Services, (Government Employees Conduct) Rules, 2016. Thus, she caused a total loss of ₹180304/- to the State Exchequer.

Thereafter, Smt. Ragini Sharma submitted reply to the said charge-sheet and denied all the allegations leveled against her. Thereafter, Shri Manoj Kumar Bansal, Chief Engineer (Retd.) was appointed as Inquiry Officer vide order dated 10.06.2025 to hold regular departmental enquiry into the allegations. The Inquiry Officer submitted his report dated 08.08.2025, wherein the charged officer was found guilty and recommended that an amount of Rs. 71472/- is to be recovered from charged officer. In the interest of justice, Smt. Ragini Sharma was granted opportunity of personal hearing on 07.01.2026. The charged officer has deposited the amount of Rs. 71472/- through challan GRN No. 0145719039 dated 16.01.2026 and requested to drop all the charges levelled against her.

On perusal of reply submitted by the charged officer and the relevant file, it is found that, the charged officer has deposited Rs. 71,472/- pointed out in the inquiry report. Further, she has been retired on 31.08.2024. In view of this, taking a lenient view, punishment of "Censure" is imposed on the charged officer.

It is ordered accordingly.
