Whereas, your name i.e. Smt. Priyanka D/o Sh. Parmanand bearing Roll No. 3592 have been recommended by Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Sanskrit** vide recommendation No. RG-15/2024/14658 dated 07.02.2025 against Advt. No. 34/2024 for Mewat Cadre. While, recommending your name, the Haryana Public Service Commission, Panchkula made observation as under:-

*"The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfill all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission."*

Accordingly, Document Verification Committees were constituted to verify the documents and you were called for verification of documents on 23.02.2025 along with other candidates. But, you remained absent for document verification. Thereafter, one more opportunity was granted to you for verification of document on 08.05.2025 vide notice dated 02.05.2025. But, you again failed to appear before document verification committee for verification of document and no re-presentation has been received from you for willingness for joining to the post of PGT Sanskrit for Mewat Cadre.


Thereafter, Department served show cause notice upon you vide letter No. 6/12-2025 PGT-1 (2) dated 17.10.2025 to submit your reply as to why your candidature be not cancelled due to you absence before Document Verification Committee for verification of your documents despite giving appropriate opportunities, however, no reply has been submitted by you till date. This notice was sent to you at your respective


