





Whereas, the petitioner had filed the Civil Writ Petition No. 35537 of 2025 titled as "Sanjay Kumar Vs. State of Haryana & Others" before the Hon'ble Punjab and Haryana High Court, praying therein for issuance of a writ in the nature of Mandamus for directing the respondents to regularize the service of the petitioner as services of Junior to the petitioner has already regularized.

The above said writ petition came up for hearing on 01.12.2025, and on that day, the Hon'ble High Court was pleased to dispose of the same with direction to respondent No.2 to decide the representation of the petitioner. The operative part of the said order is reproduced as under:-

**3. Notice of motion.**

**4. Mr. Amit Sahni, Additional Advocate General, Haryana assisted by Mr. Harmanjit Singh Johal, Advocate, accepts notice on behalf of the respondents/State and submits that in case any such representation is filed by the petitioner within two weeks from today, the same will be decided by the second respondent/Director General, Education, by passing a speaking order in accordance with law within a period of three months of receiving the representation.**

**5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.**

**6. Ordered accordingly.**

In compliance of the above said direction of the Hon'ble High Court, the representation dated 10.12.2025 of the petitioner was examined by the department and after examination it has been found

that the petitioner was engaged as a part time class IV employee against unsanctioned post of class IV in Govt. Primary School, Mitathal on 03.12.1997 and the service of the petitioner was regularized in light of the departmental regularization policy dated 11.11.2003 vide order No. E-4/2023/130-155 dated 20.02.2023 and after his regularization he joined in GGSSS Mitathal (Bhiwani). However, the detail of the petitioner is given as under in the tabular form:-

Whereas, as per the departmental regularization policy dated 11.11.2003, a common district level common seniority list of all the part time class IV employees working in Govt./Primary/Middle/High/Sr. Secondary Schools and the field offices like O/o BEOs/ SDOs/DPEOs/DEOs/SCERT/DIETs/GETTIs etc. as on 30.06.2003 was prepared by the DEOs concerned at District Level and this seniority list of part time Class-IV employees acts as a reference point for sponsoring the names of the senior most person for regularization against the regular sanctioned post of Class-IV in the field offices/Schools of the Education Department. Accordingly petitioner stood at seniority no.570.

It is pertinent to mention here that, in the light of policy dated 11.11.2003 only those part time Class-IV employees were regularized who were appointed upto 30.06.2003. The petitioner quoted example of Sh. Dhoop Singh who was engaged as a part time class-IV employee on 02.03.2002 in GGHS, Badesra (Bhiwani) but his services were inadvertently regularized vide Order no. E-1 -2019/5355-57 dated 10.09.2019. But when the case of Dhoop Singh was re-examined in view of the order dated 19.07.2019 passed by the Hon'ble High

Court in CWP No. 16086 of 2019 titled as Pushpa Devi & Others vs. State of Haryana & Others by the district level committee, headed by DEO, then it has been found that Sh. Dhoop Singh was junior to the petitioner and wrongly regularised before the petitioner and in context of that inadvertent regularization, show cause notice has been issued to him by the Principal vide order no.738 dated 07.03.2026 to explain his position.

Whereas, the petitioner was regularized w.e.f.20.02.23 vide Order No. E-4/2023/130-155 dated 20.02.2023 in GGSSS Mitathal (Bhiwani) in view of the departmental regularization policy dated 11.11.2003 as per his seniority, eligibility as well as the availability of vacant sanctioned post of class IV.

Thus, keeping in view of the position explained above, the claim of the petitioner demanded through representation dated 10.12.2025 is not tenable and hence rejected being devoid of merits.

I order accordingly.
