3. Concerned DDO is also requested to update and approved MIS data of the official at your own level & the MIS updating of the official not be updated as transfer, it should be as deputation.
4. If there is no vacancy in the destination school/office for any reason the incumbent deputed shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
5. It is his/her responsibility to report on his actual posting station on completion of deputation period.
6. The salary of the officials be drawn from his actual posting station.

Whereas, Sh. Raj Kumar [022527] Principal, GSSS, Jind [1506] was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 25/86-2024 HRG-I (1) dated 21.10.2025/27.10.2025 and the following charges were leveled against him:-

1. That he i.e. Sh. Raj Kumar being Principal, Government Senior Secondary School, Jind mentally harassed Smt. Krishna, the then Special Teacher posted at Government Senior Secondary School, Jind by making her sit outside the school office.
2. That some teachers confirmed that he i.e. Sh. Raj Kumar offered Smt. Krishna, Special Teacher to sit on his scooter for taking lunch in a hotel.
3. That he i.e. Sh. Raj Kumar being Principal exerted pressure on the staff members by calling them into meetings in the office so that they support him i.e. Sh. Raj Kumar for compromise against the allegations made by Smt. Krishna, Special Teacher. Some teachers confirmed this charge/ allegations.

Delinquent i.e. Sh. Raj Kumar, Principal submitted reply to the said charge-sheet on dated 06.11.2025 and denied all the allegations leveled against him. Thereafter, Dr. Parveen Kumar Garg was appointed as Inquiry Officer vide order dated 19.12.2025/30.12.2025 to hold regular departmental enquiry into the allegations. The Inquiry Officer submitted his report dated 22.01.2026, wherein it has been concluded that the charges levelled against him in the charge sheet does not stand proved. In the interest of justice, the charged officer was granted an opportunity of personal hearing on 11.03.2026. Sh. Raj Kumar appeared for personal hearing and reiterated the submissions made before the enquiry officer.

I have examined the documents available on the file and have heard the charged officer. The inquiry officer has not proved the charges leveled in the charge sheet. In view of the facts of the case, circumstances and the findings of the Inquiry Officer, present charge sheet against Sh. Raj Kumar, Principal is hereby 'dropped'.

I order accordingly.
