Whereas, Smt. Meenu Narang and others have filed CWP No. 6801 of 2026 titled as Meenu Narang and others V/s State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein that they may be granted age relaxation against the Advt. No. 23/2026 dated 05.02.2026 advertised by the Haryana Public Service Commission for the post of PGT Computer Science, so that, they may submit their application forms.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 09.03.2026 with following orders/direction:-

***".....Learned State counsel submits that in case the petitioners file an appropriate representation, the same shall be decided by respondent no.1/ Additional Chief Secretary to Government of Haryana, by passing a speaking order in accordance with law within three weeks therefrom.***

***In view of the statement made, learned senior counsel for the petitioners has no objection to the petition being disposed of in terms thereof.***

***Ordered accordingly."***


In compliance with the aforesaid orders, the representation dated 10/11.03.2026 submitted by the petitioners has been examined in detail in light of the relevant facts, applicable rules, and governing instructions. Upon such examination, it is observed that Advertisement No. 13/2019 was initially issued by the Haryana Staff Selection Commission, Panchkula for recruitment to various posts of Post Graduate Teachers, including 1373 posts of PGT



Computer Science. The said advertisement prescribed the age limit of 18 to 42 years, with relaxations admissible to various reserved categories in accordance with Haryana Government instructions. However, no recruitment process was concluded pursuant to the said advertisement, and the same was subsequently withdrawn.

Thereafter, fresh advertisements bearing No. 31/2022 and 32/2022 were issued by the Haryana Public Service Commission, Panchkula for similar posts. These advertisements also prescribed similar eligibility conditions, including age criteria and permissible relaxations. However, these advertisements too could not culminate into final selection and were withdrawn without completion of the recruitment process. Subsequently, Advertisement Nos. 26/2023 and 36/2023 were issued by the Haryana Public Service Commission, Panchkula for recruitment to the posts of PGT Computer Science in Rest of Haryana and Mewat Cadres. In these advertisements, a conscious policy decision was taken to grant one-time relaxation to candidates who had applied in response to earlier advertisements, whereby their eligibility conditions, including age, were considered with reference to the earlier cut-off dates, in view of the fact that the earlier recruitment processes had been withdrawn without completion.

It is further a matter of record that the selection process pursuant to Advertisement Nos. 26/2023 and 36/2023 has since been completed, and the result of the subject knowledge test was finalized on 05.02.2026. However, only 39 candidates were able to qualify against a large number of advertised posts, resulting in substantial vacancies remaining unfilled. Consequently, the Haryana Public Service Commission, Panchkula issued a fresh Advertisement



No. 23/2026 dated 05.02.2026 for filling up the remaining vacant posts of PGT Computer Science in both Rest of Haryana and Mewat Cadres.

The said Advertisement No. 23/2026 constitutes a fresh and independent recruitment process, which is required to be governed strictly in accordance with the applicable statutory rules and Government instructions. The eligibility conditions, including the prescribed age limit and admissible relaxations, have been clearly specified therein, and the same are uniformly applicable to all candidates. The contention of the petitioners that they should be granted age relaxation on the ground that they were eligible in earlier advertisements, particularly Advertisement Nos. 26/2023 and 36/2023, has been carefully considered. However, such a claim cannot be sustained in law, as the earlier recruitment process has already been concluded and cannot be reopened or extended to a subsequent and independent advertisement.

Age relaxation can only be granted to those categories of candidates who fall within the ambit of the applicable Government instructions. The petitioners do not fall under any such prescribed category and are seeking relaxation solely on equitable or sympathetic grounds. It is settled law that relaxation in eligibility conditions, particularly age, cannot be granted de hors the statutory rules and must be exercised strictly within the framework of the governing provisions.

Accordingly, after due consideration of all relevant facts, circumstances, and applicable instructions, it is concluded that the claim of the petitioners for grant of age relaxation in the present recruitment process is not tenable in law. The present Advertisement

No. 23/2026 being a fresh recruitment process, the benefit of any earlier relaxation cannot be extended. Consequently, the representation submitted by the petitioners is liable to be rejected.

I order accordingly.

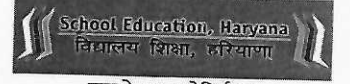

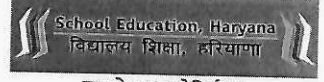

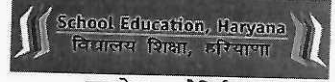
