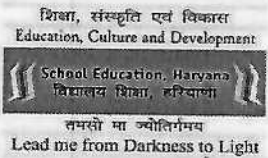

Whereas, Sh. Satish Kumar Sangwan Clerk, O/o DEEO, Faridabad, was dismissed from services vide order dated 31.10.2025 on his conviction by Trial Court in FIR No. 207 of 2012 & Case No. CHI-0020014 OF 2014, decided on 16.07.2024. Thereafter he filed an Appeal CRA No.219 of 2024 titled as Surender Kumar & Another Vs State of Haryana, before the Additional District and Session Judge against the Order dated 16.07.2024 passed by Trial Court. The Appeal was listed on 14.11.2025 and the Court of Additional District and Session Judge, Faridabad, suspended the conviction of Sh. Satish Kumar Sangwan Clerk. The order dated 14.11.2025 is reproduced here as under :-

“The Criminal Appeal in hand of convict Satish Kumar son of Shamsher Singh, was pending for arguments, for 08.01.2026. Same was however, put up, vide an application under Section 389 of the Cr.P.C., on his behalf, by his Ld. Counsel pleading that although, the order of sentence passed against him by the Ld. Trial Court in FIR No. 207 dated 11.08.2012 under Sections 420, 467, 468, 120-B etc. of the IPC registered, at Police Station SGM Nagar, Faridabad, had been suspended by this Court of appeal, vide order dated 08.08.2024, since he was a Government Official (as clarified, vide his application dated 11.11.2025) and designated as the Clerk, with Employee ID 092934 in the Office of District Education, Sector-16, Faridabad, he was under an apprehension that he might suffer from a certain disqualification provided for in other Statute/Departmental Proceedings etc., it was urged that vide his application in hand, the order of conviction be also, suspended else he would suffer an irreparable loss.

- 2. Notice of the application in hand, issued to the State of Haryana.*
- 3. Submissions of both the parties, considered.*
- 4. In view, of the law laid down in Rama Narang Versus Ramesh Narang and Ors., (1995) 2 SCC 513 and Navjot Singh Sidhu Versus State of Punjab & Anr., AIR 2007 SC 1003, since an appeal has been preferred under Section 374 of the Cr.P.C., it is deemed to be the appeal against both, the conviction and sentence. The legal position is therefore, clear that an Appellate Court can suspend or grant stay of order of conviction, or drawing of attention of the Appellate Court to the consequences that may arise if, the conviction was not stayed.*
- 5. Considering, that the appellant/convict was a government official, deputed as a Clerk in a Department of Government of Haryana (i.e. District Education Office, at Sector 16, Faridabad), the fact corroborated by annexing a copy of his ID Card, this Court is satisfied that a case is made out for grant of order of suspension of conviction, as prayed for.*
- 6. Accordingly, the impugned order of conviction, as challenged before this Court, is suspended.*
- 7. The application dated 06.11.2025 and subsequent one dated 11.11.2025 of the appellant/convict Satish Kumar, stands allowed.*

Disposed of.”

Thereafter Sh. Satish Kumar Sangwan also filed a CWP No.37355 of 2025 challenging there in his dismissal order dated 31.10.2025, which was disposed of by the Hon'ble High Court, vide its order dated 15.12.2025, with a direction to respondent No.2 (Director General Secondary Education) to consider and decide his representation dated 17.11.2025. The operative part of the order is reproduced as under:-

" In view of the above and without commenting upon the merits of the case, this petition is hereby disposed of with a direction to respondent No.2 to consider and decide the representation dated 17.11.2025 (Annexure P-4), submitted by the petitioner within a period of 01 month from the date of receipt of certified copy of this order in accordance with law."

In compliance of aforesaid order passed by the Hon'ble High Court and due to suspension of Conviction by Appellate Court Sh. Satish Kumar Sangwan is hereby reinstated in service subject to final outcome/decision of CRA No.219 of 2024 titled as Surender Kumar & another Vs State of Haryana and further litigation if any. He is hereby directed to report in the Office of DEEO, Faridabad for submission of his joining report.

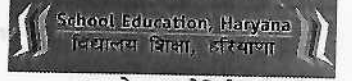
