Whereas, R.D.S. Memorial School, Pengaltu, Palwal was granted temporary recognition for classes up to 10th vide order no. C.C.C/2000/2534-2538 dated 08.08.2000 by the District Education Officer, Palwal.

Whereas a complaint has been received through CM Window from the complainants namely Sh. Udayveer and Sh. Jageram, regarding R.D.S. Memorial School, Pengaltu, Palwal, wherein it has been requested that action be taken for cancellation of recognition of the said school.

Whereas, the complaint was forwarded to the District Education Officer, Palwal for verification and submission of a factual report. In response thereto, the District Education Officer, Palwal, vide letter No. Steno/23/1633 dated 02.01.2023, has reported that the school is not complying with the provisions of the Haryana School Education Rules, 2003 and has also failed to furnish replies to the information sought by this office as well as by the office of the Block Education Officer, Hodal. In view of these facts, the District Education Officer, Palwal has recommended cancellation of recognition of the school as school is not following instructions of the District Education Officer. It has further come to notice that the Board of School Education, Haryana, Bhiwani, vide order No. 4350/Affiliation/A-6 dated 11.11.2022, has withdrawn the affiliation of the school for the academic session 2023-24 on account of violation of Affiliation Regulations 10(B)(C)(A) and 21(1)(E).

Whereas, R.D.S. Memorial School, Pengaltu, Palwal was granted recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time.

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution.

(2) The recognition/NOC of the school shall lapse if the school,-
