Whereas, Smt. Vanita has filed CWP No. 3393 of 2026 titled as Vanita Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein to issue a writ in nature of mandamus directing the respondents department to promote the petitioner to the post of PGT Hindi w.e.f. 13.06.2025 that is the date on which the junior TGT teachers were given promotions with all the consequential benefits.

The above mentioned writ petition came up for adjudication on 09.03.2026 and the Hon'ble Court disposed of the same vide order dated 09.03.2026. The operative part of the same is as under: -

"..... Notice of motion.

4. Ms. Tanushree Gupta, Senior Deputy Advocate General, Haryana accepts notice on behalf of the respondents no. 1 and 2/State and submits that the pending representation dated 21.08.2025, will be decided by respondent no.2/ Director General, Secondary Education, by passing a speaking/reasoned order in accordance with law within a period of three months.

5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly.

7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of 50,000 to the petitioners."

In compliance with the above said order dated 09.03.2026, the representation dated 21.08.2025 has been duly examined. The petitioner has contended that she is entitled to be promoted to the post of PGT Hindi with effect from 13.06.2025, i.e., the date on which her juniors were promoted.

Whereas, as per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion of Hindi PGT (Post Graduate Teacher) is as under:-

By promotion:-

M.A. Hindi with atleast 50%marks and B.Ed from recognised university; AND

2 years teaching experience as TGT Hindi/ Hindi teacher;



It is evident from the aforesaid rule that, in order to be eligible for promotion to the post of PGT Hindi, a teacher must have rendered a minimum of two years of service as TGT Hindi/Hindi Teacher.

Whereas, Vanita [1013080] was initially appointed as JBT Teacher on a regular basis on 21.12.2004. Thereafter, she was promoted to the post of TGT Sanskrit vide order dated 01.03.2019 and joined her duties as TGT Sanskrit on 06.09.2019. At present, she is working as TGT/C&V Sanskrit. It is pertinent to mention here that the service conditions, including promotion avenues, are governed by the Haryana State Education School Cadre (Group-B) Service Rules, 2012. As per the said Rules, there exists no provision for promotion to the post of PGT Hindi from the cadre of TGT/C&V Sanskrit. Therefore, the claim for promotion to the post of PGT Hindi from the post of TGT/C&V Sanskrit is not admissible under the prevailing rules.

In view of the facts mentioned above, the representation dated 21.08.2025 submitted by the incumbent, along with the documents available on record has been examined. It is observed that she is presently working as TGT/C&V Sanskrit not as TGT Hindi/Hindi Teacher. In light of the applicable rules and the position explained hereinabove, the claim of Smt. Vanita for promotion is not tenable. Accordingly, her representation is hereby rejected due to the reasons stated above and being devoid of merits.

I ordered accordingly.
