**Terms and conditions:-**

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.

6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. 



Whereas, Shri Ved Singh Dahiya [018861], the then District Elementary Education Officer, Fatehabad [now DEO Hisar] was charge-sheeted under rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/189-2025 HRG-I (2) dated 19.08.2025 and the following allegations were levelled against him:-

*“That he i.e. Sh. Ved Singh Dahiya being the then District Elementary Education Officer, Fatehabad submitted wrong information before the Hon’ble Punjab and Haryana High Court Chandigarh on 01.10.2024 at the time of hearing of Civil Original Contempt Petition No. 993 of 2024 titled as Ishpati Versus Dr. G. Anupama, Additional Chief Secretary to Government Haryana, School Education and Civil Original Contempt Petition No. 984 of 2024 titled as Usha Rani Vs Dr. G. Anupama, Additional Chief Secretary to Government Haryana, School Education that the case of the petitioners already stands forwarded to the Finance Department and the financial benefits of the petitioners shall be released within a period of two weeks from today due to which the Hon’ble Punjab and Haryana High Court passed adverse orders on 10.03.2025 as he i.e. Sh. Ved Singh Dahiya failed to follow the orders dated 01.10.2024 passed by the Hon’ble High Court.*

*That in the matter, he i.e. Sh. Ved Singh Dahiya being District Education Officer has not applied his mind while passing the orders vide No. E-3/2024/10313-19 dated 22.08.2024 regarding the regularization of the services of both the petitioners i.e. Ishpati and Usha Rani by showing the different dates of their regularization.*

*That he i.e. Sh. Ved Singh Dahiya was directed by the Directorate of Elementary Education Haryana vide Memo No. 3/174-2024 PP(2) dated 23.12.2024 to supply the information within 3 days positively through special messenger regarding the Civil Original Contempt Petition No. 984 of 2024 titled as Usha Rani Vs Dr. G. Anupama, Additional Chief Secretary to Government Haryana, School Education and also directed vide Memo No. 3/175-2024 PP(2) dated 23.12.2024 to supply the information within 3 days positively through special messenger regarding the Civil Original Contempt Petition No. 993 of 2024 titled as Ishpati Vs Dr. G. Anupama, Additional Chief Secretary to Government Haryana, School Education, but he i.e. Sh. Ved Singh Dahiya failed to comply the same whereas the information was supplied by his successor i.e. Smt. Sangeeta Bishnoi having charge of District Elementary Education Officer, Fatehabad vide letter No. E-3/2025/1337-38 dated 25.02.2025, which shows his callous approach to dealt with the Court Cases as well as directions of the higher authorities. Thus, he i.e. Sh. Ved Singh Dahiya failed to supervise and monitor the aforesaid both contempt petitions at his level being Head of the District.”*

Thereafter, the charged officer submitted his reply dated 06.10.2025 to the said charge-sheet and denied all the allegations levelled against him. He has stated in his reply that as per direction of the directorate vide letter No. 17/130-2022 TGT R&A (4) dated 21.08.2024 and in compliance of judgment dated 20.09.2022 passed by the Hon'ble High Court in CWP No. 20339/2011, the services of the petitioner was regularized w.e.f. 01.10.2023 vide order No. E-3/2024/10313-320 dated 22.08.2024. He has further mentioned that the pension branch of the Directorate has not pursued the order of regularization of service properly and considered tabulated fact of date of retirement of petitioners i.e. 31.08.2013 & 30.11.2011 as date of regularization of services of petitioner. He has also stated that he was remained on earned leave on medical ground w.e.f. 23.12.2024 to 03.01.2025 and no fresh letter after memo dated 23.12.2024 was received to him and after that he was transferred from the post of DEEO Fatehabad to the post of DEO Sirsa on 31.01.2025.

On perusal of the reply of the charged officer and documents on record, the competent authority has observed that the charged officer did not comply with the directions of the directorate, however, no loss has been caused to the State exchequer. Further, Hon'ble High Court disposed of the contempt petition on 15.07.2025. In the circumstances, the competent authority has decided to take a lenient view, accordingly, the present charge sheet issued to Shri Ved Singh Dahiya [018861], the then DEEO Fatehabad now DEO Hisar is hereby filed.

It is ordered accordingly.
