**Terms and conditions:-**

1. If any, disciplinary proceeding under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rule, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. The promotee(s) will remain on probation for one year as per Rule 27 of Haryana Civil Services (General) Rules, 2016.
3. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
4. The promotion has been given on the basis of availability of 70% or more records falling in the category of good or better than that and in the eventually of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
5. If any discrepancy regarding not fulfilling the essential qualifications and requisite experience as prescribed in the Haryana Education Department, Sub Office, Ministerial (Group-B) Service Rule 1998, the said incumbent(s) shall be reverted without issuing any notice.
6. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
7. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
8. The District Education Officer concerned shall ensure compliance of above conditions before letting the promoted Superintendent to join.
9. They will remain on probation for a period of one year which can be extended as per Service Rules.
10. In case they do not join the promotional post within 15 days their claim will be rejected as per rules.
