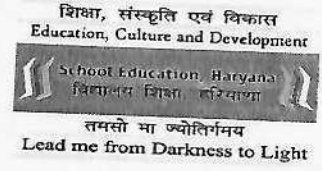



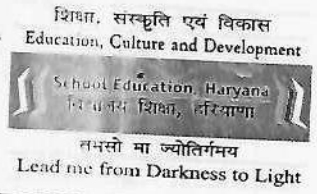

Subject:- Regarding cancellation of candidature of Sh. Nitin S/o Sh. Mahender Pal bearing Roll No. 5580 newly selected PGT Geography.

In reference to the subject cited above.

Vide recommendation No. RG-15/2024/14695 dated 11.02.2025, you bearing Roll No. 5580 was recommended by Haryana Public Service Commission, Panchkula for the post of PGT Geography against Advt. No. 24/2024 along-with other candidates having Merit No. 11 under General category. While recommending Commission has made following observation:-


“The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them alongwith their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 22.02.2025, but you were absent during verification of documents. Thereafter, one more opportunity was given for verification of documents by the department on 08.05.2025, but you again failed to appear before document verification committee. Thereafter, you



were issued a show cause notice dated 21.01.2025 as to why your candidature be not cancelled and directed to submit your reply within 15 days. The notice has been conveyed to you through Registered post, Email and through District Education Officer concerned. In response of above notice, you intimated vide Email dated 07.03.2026 that you are already working as Government Service and not willing to join duties to the post of PGT Geography against advertisement 24/2024.

Keeping in view of the above, the notice dated 21.01.2026 is confirmed and your candidature for the post of Post Graduate Teacher Geography (ROH Cadre) against Advt. No. 24/2024 is hereby cancelled.

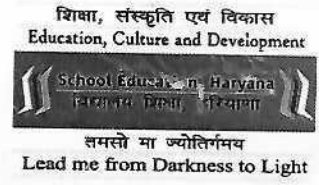
