5. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she

If in the verification it reveals that any certificate is found false then your appointment will be cancelled without any notice.



11. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
12. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
13. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
14. No TA/DA will be admissible to the candidate for joining as PGT.
15. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
16. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
17. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provision of Indian Penal Code (IPC) etc as deemed fit.
18. The said appointment are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in CS Haryana instruction No. 52/08/2022-3GS-III dated 23.06.2022 and 52/06/2018-2HR-III dated 05.02.2024.
19. The concerned candidate is directed to join duties at place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.

Whereas, Sh. Parvesh Kumar, Clerk O/o District Elementary Education Office, Karnal was charge sheeted under rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order No. **5/41-2025 HRME-I (3)** dated 30-10-2025 wherein the following charges were levelled against him:-

“कोर्ट केस सी0डब्ल्यूपी0 न0 18550 आफ 2025 में जारी पत्र दिनांक 04.08.2025 व 11.08.2025 अनुसार व आपको दूरभाष पर बार-बार सम्पर्क करने के बावजूद भी आपके द्वारा संतोषजनक कार्यवाही नहीं की गई, जोकि उच्च अधिकारीगण के आदेशों की अवहेलना को दर्शाता है।”


Thereafter, the charged official submitted his reply to the said charge sheet vide letter dated 28-11-2025 and he denied all the allegations levelled against him.

The reply of the charged official was found un-satisfactory. Resultantly, Smt. Paramjit Kaur, Senior Research Officer was appointed as Inquiry Officer vide Order No. 5/41-2025 HRME-I (3) dated 09.12.2025. The inquiry officer submitted her report on 15.01.2026, wherein the Inquiry Officer had concluded as under:-

Therefore, keeping in view of report of the Inquiry Officer and facts of the case, I am of the considered view that a recorded warning be issued to Sh. Parvesh Kumar, Clerk O/o District Elementary Education Officer, Karnal with the direction to be careful in future.

I, order accordingly.
