Whereas, Shri Munish Kumar, [026166] Senior Lecturer O/o DIET Shahpur [4613] Karnal was charge sheeted under Rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 03.02.2026 and the following allegations were leveled against him :-

1. That he i.e. Sh. Munish Kumar, Senior Lecturer, DIET Shahpur (Karnal) refused to accept lawful orders issued by the competent authority whereas the workload among all available employees was distributed in a uniform manner vide this office order No. 978 dated 23.10.2023. That he further refused to accept/comply with subsequent office orders No. 980 dated 04.11.2023, No. 989 dated 05.12.2023 and No. 996 dated 27.12.2023, stating that he would himself decide what duties to undertake in the office.
2. That he i.e. Sh. Munish Kumar has denied to perform his duty assigned vide order number 980 dated 04/11/2023 to attend the Training of Trainers (TOT) on Drug De addiction of the children studying in the schools under the title 'Navchetna' held at the State Council of Educational Research and Training (SCERT) Haryana at Gurugram from dated 06.11.2023 to 08.11.2023.
3. That he i.e. Sh. Munish Kumar misbehaved on dated 13/12/2023 with his senior officer and the Principal DIET Shahpur Karnal by shouting and thumping the table top of his officer and passing derogatory remarks.
4. That he i.e. Sh. Munish Kumar has illegally signed on the order of nominated employees and master trainers as per mentioned schedule of the mission Haryana KarmYogi training at the allocated training centers/ venues in the Karnal District' document dated 16/12/2023 whereas, he was not entitled whatsoever to sign such a document on behalf of senior officers' without any permission in written or verbal.
5. That he i.e. Sh. Munish Kumar uploaded defamatory and derogatory content on the official WhatsApp platform of DIET Shahpur (Karnal) and other teaching fraternity groups on 29.12.2023, intending to defame the institution and the Education Department without any basis or evidence.
6. That he i.e. Sh. Munish Kumar obstructed official Government duties on 27.12.2023 by unauthorizedly entering the Teacher of Training on POCSO Act classroom in pursuance vide Directorate memo No. 3/3-2023 TPMC(2) dated 22.12.2023), interrupting proceedings for nearly half an hour and hindering trainees and the master trainer.

The charged officer submitted his reply dated 19.02.2026 to the aforesaid charges and denied all the allegations levelled against him and requested to drop the charge sheet under rule -8. In the interest of justice, charged officer was granted an opportunity of personal hearing to explain his position on 17.04.2026.

The matter was considered and after going through the facts, record and circumstances of the case charge sheet dated 03.02.2026 is hereby filed.

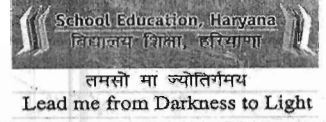

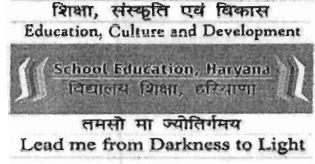
