ORDER

Terms and conditions:-

1. The candidate is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive

post shall be considered on the basis of his/her seniority and record of service as and when such post is available.

2. The candidate shall have to take an oath of allegiance to the Constitution of India.
3. In case the candidate is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If the candidate has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. The candidate shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
6. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate from issuing authority. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is found false then the service of the candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District

Education Officer concerned alongwith photostat self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter educational qualification certificates be got verified from the issuing authority within 03 months. If in the verification it reveals that any certificate is found false then your appointment will be cancelled without any notice.

9. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
10. The candidate shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
11. If at any time during the course of temporary appointment, the candidate desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
12. No TA/DA will be admissible to the candidate for joining as PGT.
13. If the candidate gets an appointment as PGT on the basis of furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, the candidate would be liable for termination of service without any notice.
14. This appointment letter is provisional subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
15. If in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in the self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken as per provisional of Indian Penal Code (IPC) etc as deemed fit.

Sudharshan Sharma [029659], Principal, Shaheed Girdhari Lal GMSSSS, Siwan [2171] Kaithal was charge-sheeted under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/359-2022 HRG-I (1) dated 27.02.2025 and the following charges were leveled against him:-

"That a complaint dated 07.04.2021 made by Sh. Neeraj Rana Son of Shri Jagmal Rana, resident of Village Gohran, Tehsil and District Kaithal against Baba Balak Nath Public School Village Gohran, District Kaithal regarding running of said school on the basis of false and forged documents was received. Accordingly, Smt. Sunita Devi, Joint Director (Academic) was appointed as Inquiry Officer to conduct preliminary enquiry. The Enquiry Officer submitted her report on dated 22.12.2021, wherein following irregularities were found to be committed by him i.e. Shri Sudarshan Sharma being the then Block Education Officer, Siwan, District Kaithal.


He i.e. Shri Sudarshan Sharma was directed as District Level Committee Member by the District Elementary Education Officer, Kaithal to inspect Baba Balak Nath Public School, Gohran (Kaithal) for recognition. Consequently, he i.e. Shri Sudarshan Sharma being a committee member of the committee, inspected the Baba Balak Nath Public School, Gohran (Kaithal) on 04.11.2020 and submitted his report on dated 06.11.2020 along with recommendation that the school is fit for recognition upto 8th standard. In the report it was also mentioned that the building of the school i.e. Baba Balak Nath Public School, Gohran (Kaithal) is constructed in Khasra No. 25, Killa No. 19/1, 19/2, Khewat No. 73-74 whereas the same was constructed in Khewat 75, Khatoni No. 154, Murraba No. 21 of Khasra No. 25/1(5-6) which is a Government Panchayati Land (as per report of enquiry officer/ dated 22.12.2021). As he i.e. Shri Sudarshan Sharma, the then Block Education Officer-cum-Member of the Inspection Committee failed to mention actual facts and mislead the higher authority by submitting false report, which is grave misconduct on his part i.e. Shri Sudarshan Sharma."

Thereafter, Shri Sudarshan Sharma [029659] submitted reply to the said charge-sheet on dated 05.03.2025 and denied all the allegations leveled against him. Thereafter, Dr. Narinder Kumar Arora, DGHS (retd.) was appointed as Inquiry Officer vide order dated 22.04.2025 to hold regular departmental enquiry into the allegations.

The Inquiry Officer submitted his report dated 24.07.2025, wherein the charges levelled against the charged officer found not proved. Thereafter, he was given personal hearing on 25.03.2026.



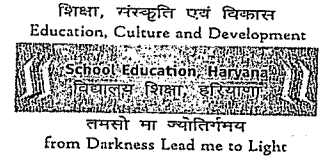

4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.


