With reference to the subject cited above, it is stated that vide Recommendation No. RG-15/2024/14655 dated 07.02.2025, you bearing Roll No. 6177 were recommended by the Haryana Public Service Commission for the post of PGT Sociology against Advt. No. 35/2024 under General Category along with other candidates. While making the recommendation, the Commission observed as under:

“The Commission has interviewed and recommended the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfill all conditions of Educational Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been medically examined and no special enquiry into their antecedents has been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents, and all the recommended candidates were called for verification of their documents on 22.02.2025. Thereafter, appointment letter was issued in your favor vide Office Order No. 6/14-2025 PGT-1(2) dated 21.04.2025 with directions to join the allotted station within 15 days. However, you failed to join your duties and requested for extension of joining period for three months through your E-mail dated 07.05.2025. Considering your request, the Department granted an extension of three months in the joining period vide Office Order No. 6/14-2025 PGT-1(2) dated 07.07.2025 with directions to join your duties by 06.08.2025. Despite the grant of extension, you again failed to join the post of PGT Sociology. Thereafter, a final opportunity was provided to you vide notice dated 12.12.2025 directing you to join at the allotted station by 26.12.2025. It was clearly mentioned in the said notice that no further opportunity for joining would be granted. The notice was conveyed to you through Registered Post, E-mail, and through the concerned District Education Office.

However, you again failed to join your duties and further requested for additional time on account of ongoing health issues. Upon examination of your request, it has been observed that despite being provided sufficient opportunities and adequate time in accordance with



Government rules and instructions, you failed to join your duties to the post of PGT Sociology. Therefore, your request for grant of further extension in joining time is not tenable.

Keeping in view of the above facts and circumstances, the notice dated 12.12.2025 is hereby confirmed and your candidature for the post of Post Graduate Teacher Sociology (Rest of Haryana Cadre) against Advt. No. 35/2024 is hereby cancelled.

**Subject: - Cancellation of candidature for the post of PGT Sociology
against Advt. No. 35/2024.**

With reference to the subject cited above, it is stated that vide Recommendation No. RG-15/2024/14655 dated 07.02.2025, you bearing Roll No. 6036 were recommended by the Haryana Public Service Commission for the post of PGT Sociology against Advt. No. 35/2024 along with other candidates. While making the recommendation, the Commission observed as under:

“The Commission has interviewed and recommended the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfill all conditions of Educational Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been medically examined and no special enquiry into their antecedents has been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents of all recommended candidates, and you were called for verification of documents on 22.02.2025. However, you remained absent during the document verification process. Thereafter, another opportunity was provided by the Department for verification of documents on 08.05.2025, but you again failed to appear before the Document Verification Committee. Subsequently, a notice dated 12.12.2025 was issued to you asking why your candidature should not be cancelled, and you were directed to submit your reply within 15 days. The said notice was communicated to you through Registered Post, E-mail and through concerned District Education. In response to the aforesaid notice dated 12.12.2025, you submitted your reply through E-



mail dated 08.04.2026 stating that you are not willing to join the post as you are preparing for Judicial Examination.

Keeping in view the facts and circumstances explained above and your unwillingness to join the post of PGT Sociology against Advt. No. 35/2024, the notice dated 12.12.2025 is hereby confirmed and your candidature for the post of Post Graduate Teacher (Sociology) (ROH Cadre) against Advt. No. 35/2024 is hereby cancelled.


