ORDER

No. 6/122-2024 PS (4)

Dated, Chandigarh, the 03-07-2024

Whereas, CBC Memorial School, Barwala, District Hisar was granted Permanent recognition for Classes IX to X vide Order No. 26/92-07 PS(4) dated 28.03.2008 by the Director, Secondary Education, Haryana, Panchkula, subject to the condition that the school shall strictly comply with the provisions of the Haryana School Education Act, 1995, the Haryana School Education Rules, 2003, and instructions issued by the competent authority from time to time.

Whereas, a Complaint has been received against CBC Memorial School, Barwala, Hisar, on the allegations that the school charged fees from the students admitted under the CHEERAG Scheme which is in violation of the scheme guidelines. It was also alleged that the school management refused to issue School Leaving Certificates (SLCs) to the concerned students and used caste-base abusive language against the complainants.

Whereas, vide order dated 16.01.2026/21.01.2026 passed by the Director General Secondary Education, after considering the available material record including the report of the District Education Officer, committee inspection reports, parents affidavits/complaints, verification of MIS data and videographic evidence, withdraw the recognition of CBC Memorial School, Barwala, Hisar.

The concerned school management, challenged the order dated 16.01.2026/21.01.2026, whereby recognition granted to the petitioner-school has been withdrawn, by way of filing writ petition bearing CWP No. 2603 of 2026 titled as CBC Memorial School V/s State of Haryana and others. The said writ petition was dismissed by the Hon'ble High Court on

02.02.2026. The operative part of order dated 04.02.2026 is reproduced here as under:-

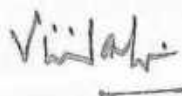
"This Court has also examined the impugned order. A complaint is pending against the petitioner-school alleging that it charged fees from students admitted under the CHEERAG Scheme, in violation of the Scheme guidelines. In order to ascertain the veracity of these allegations, a Headquarters-level Committee was constituted to inspect the school. The impugned order reflects that the petitioner not only created hindrance by not providing the requisite documents to the Committee but also threatened its members. Furthermore, affidavits and statements have been submitted by certain parents against the petitioner-school, alleging irregularities, denial of school leaving certificates, unauthorized demands for money, wrongful marking of attendance on the MIS portal, and improper claims for reimbursement under the CHEERAG Scheme. The petitioner has failed to specifically rebut these allegations.

14. In summa, this Court finds no merit in the instant writ petition, and the same is accordingly dismissed."

Whereas, the petitioner on 20.02.2026 preferred an Appeal before the undersigned against the order dated 16.01.2026/21.01.2026 passed by the Director General Secondary Education, Haryana, Panchkula

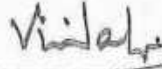
Accordingly, a reasonable opportunity of personal hearing was granted to the appellant on 10.06.2026 and heard at length. During the course of the hearing, the appellant reiterated the submissions already made in the appeal, however, he failed to produce any sustainable document or record in support of his claim. The record of the case, the grounds raised in the appeal and the submissions made during the personal hearing were carefully examined and considered.

Whereas, upon such examination, no illegality or material irregularities have been found in the order dated 16.01.2026/21.01.2026.



Therefore, the appeal filed by the applicant being devoid of merit and is hereby rejected. The order dated 16.01.2026/21.01.2026 passed by the Director General, Secondary Education, is upheld and shall remain in force.

I, therefore, pass an order accordingly.
