Terms & Conditions:-

1. The benefit of notional pay fixation and seniority will be admissible w.e.f. 13.06.2025 from the date when his/her juniors have been promoted and actual financial benefits will be admissible to her from the date when he/she joins duty as **PGT Physics**.
2. He is posted temporarily in the school with the condition that he/she must he/she must participate in the next phase of transfer drive for permanent posting.
3. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending. Subsequently, the said incumbent (s) shall be reverted without issuing any notice.
4. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
5. If subsequently, it is found that he has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

6. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
7. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
8. These promotion order is based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT (Physics)** provided those seniors are found eligible for the post.

11. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT cadre.

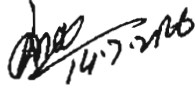
