Whereas, the names of the 16 (Rest of Haryana Cadre) selected candidates have been recommended by the Haryana Staff Selection Commission, Panchkula for appointment to the post of PGT **Sanskrit** vide recommendation no. HSSC/Confid./Recomm./01/48/2025/CA-11/346 dated 14.11.2026 against Advt. No. 04/2015, Category No.16. While, recommending the name of the selected candidate, the Haryana Staff Selection Commission, Panchkula had made an observation as under:-

“The selected candidates have not been medically examined and no special inquiry into their antecedent has been made. The documents pertaining to their Essential Qualifications, Age, Caste/Category, Universities and Experience are claimed /attached by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duty. A copy of the appointment letter issued to the candidate may also be endorsed to the Commission”

Accordingly, Document Verification Committee was constituted to verify the documents and all the recommended candidates were called for verification of their documents on 27.11.2025 and appointment letters were issued to candidates for the post of Post Graduate Teacher in the subject of Sanskrit in various subjects and directed to join their duties within 15 days at the allotted place till 15.01.2026 on the recommendations of Haryana Staff Selection Commission. But, these candidates were not joined within stipulated period and requested for further extension. On their request further extension has been granted to them and directed to join their duties till 15.04.2026. But they were again failed to their duties till 15.04.2026 and again requested for further extension due to various reasons. After examine these request, it has been decided that the last opportunity granted to them to join till **04.08.2026** before cancellation their candidature to the post of PGT.

Therefore, these candidates are again directed to join their duties at allotted station till **04.08.2026**; otherwise their candidature will be cancelled for the post of Post Graduate Teacher Sanskrit against Advt. 4/2015, Cat. 16 without any prior notice.
