Whereas, Sh. Harbans Singh has filed CWP No. 35200 of 2025 titled as Harbans Singh Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein for issuance of directions in the nature of mandamus directing the respondents to promote the petitioner on the post of PGT Hindi w.e.f. the date of junior to the petitioner have been promoted.

The above mentioned writ petition came up for adjudication on 21.01.2026 and the Hon'ble Court disposed of the same vide order dated 21.01.2026. The operative part of the same is as under: -

".....Learned State counsel, appearing on advance notice, on instructions, submits that the petitioner was appointed as JBT Teacher and was promoted as Hindi Teacher in C&V cadre on 24.02.2022, with effect from 05.05.2008 under Physically Handicapped (PH) Category. His representation dated 01.08.2025, Annexure P-16, seeking inclusion in the combined seniority list of C&V cadre under PH category is being considered along with the cases of other similarly situated candidates. She also submits that the Department will take final decision in this regard in due course, and admissible benefits in terms will be extended to the petitioner in accordance with law.

3. *In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.*

4. *Ordered accordingly."*

In compliance with the above said order dated 21.01.2026, the representation of the petitioner has been duly examined. The petitioner, namely Sh. Harbans [1000733], was initially appointed as JBT on a regular



basis on 06.10.2000. Thereafter, he was promoted to the post of C&V/TGT Hindi Teacher w.e.f. 05.05.2008 (notionally). Now, the petitioner is seeking promotion to the post of PGT (Hindi) with effect from the date on which his juniors were promoted to the said post.

Whereas, the petitioner has sought promotion under the PwD category, however, the seniority list of C & V Teachers (Persons with Disabilities) as on 01.06.2023 has been withdrawn by the Elementary Education Department due to certain technical issues vide order No. KW 22/43-2020 TGT Pro. (3) dated 17.02.2026/18.02.2026. It is further submitted that, as intimated by the Office of the Directorate of Elementary Education, the said withdrawn seniority list is presently under consideration of the competent authorities for review/finalization. In the absence of any finalized and duly confirmed seniority position, it is not feasible to evaluate or determine the petitioner's claim for promotion to the post of PGT (Hindi) at this stage.

In light of the applicable rules and the position explained hereinabove, the claim of Sh. Habans Singh for promotion to the post of PGT Hindi with effect from the date on which his juniors were promoted is not tenable at this stage. Accordingly, the claim of Sh. Habans Singh is hereby rejected for the reasons stated above.

I ordered accordingly.

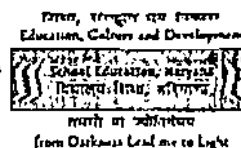

1. The benefit of notional pay fixation and seniority will be admissible w.e.f. 06.05.2016 from the date when their juniors have been promoted and actual financial benefits will be admissible to them from the date when they join duty as PGT Hindi.
2. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending. Subsequently, the said incumbent (s) shall be reverted without issuing any notice.
3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
4. If subsequently, it is found that they have done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008

decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
6. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
7. These promotion order is based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as PGT (Hindi) provided those seniors are found eligible for the post.

10. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT cadre.

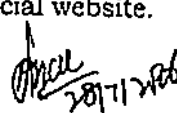
