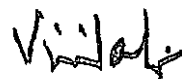
Whereas, Sh. Rajesh Kumar [096704], Principal, Government Senior Secondary School, Umra [828] Nuh was charge-sheeted under Rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/154-2025 HRG-I(1) dated 17.07.2025 and the following charges were leveled against him:-

"That 31 students were appeared in Senior Secondary Examination 2025 but only 3 students were qualified the aforesaid examination and thus, the board results of Senior Secondary Education Examination 2025 of your school remained only 9.68% even though adequate staff remained posted in your school. Thus, your approach to remain, callous towards result orientation, as the school performed so badly, contributing in tanking the overall result of the state which is a lapse on your part."

That charged officer submitted reply to the charge sheet on 01.08.2025 and denied all the charges levelled against him. Thereafter, he was granted an opportunity of personal hearing by Director General Secondary Education on 08.10.2025 and finding his reply unsatisfactory punishment of stoppage of one increment without cumulative effect was inflicted upon him vide order dated 19.11.2025/20.11.2025. Aggrieved from the order dated 19.11.2025/20.11.2025, Sh. Rajesh Kumar preferred appeal dated 16.12.2025 under rule 9 of Haryana Civil Service (Punishment & Appeal) Rules, 2016. He was granted an opportunity of personal hearing on 26.05.2026. During the course of hearing, he stated that 18 posts of PGT are sanctioned in his school out of which only 8 posts are filled up and out of these 8 posts, one PGT has proceeded on maternity leave and one PGT Geography has been deputed in Government Senior Secondary School, Khedli (Nuh), thus, only 6 PGTs were available in the school which is the root cause of poor performance of the school in Board Examination. He also stated that 5 students appeared in the examination who earlier got compartment, and they have now passed the examination.

The documents available on the file have been examined and in view of above, the order dated 19.11.2025/20.11.2025 passed by Director General Secondary Education is hereby set aside and the charge sheet is filed.

It is ordered accordingly.

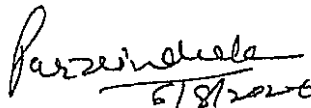

Smt. Sudesh Bala, who was working as Punjabi Teacher in the Dayanand Model Senior Secondary School, Karnal was declared surplus due to surrender of grant-in-aid by the said school. Accordingly she was adjusted in Guru Nanak Girls Senior Secondary School, Karnal. However, she was not allowed to join by said school. She filed CWP No. 28327 of 2019- titled as Sudesh Bala and Another V/s State of Haryana and Others and in compliance of the interim order dated 08-05-2023 passed by Hon'ble High Court, by relaxing the Rule 4(1)(2) of Haryana Voluntary State Education Service Rules, 2017, Smt. Sudesh Bala is hereby appointed to the post of Punjabi Teacher/TGT Punjabi in the Haryana School Education Department in the pay scale as mentioned in FPL 7 of the Schedule I of the Pay Matrix of the Haryana Civil Services (Revised Pay) Rules, 2016 plus usual allowances as admissible under the State Government Rules from time to time.

Further, she is posted in the Govt. School mentioned against her names with the following terms and conditions:-

Terms & Conditions:-

1. She is appointed purely on temporary and provisional basis.
2. This appointment is against temporary posts and her confirmation against substantive posts shall be considered on the basis of her seniority and record of service as and when such posts are available.
3. She shall take an oath of allegiance to the Constitution of India.
4. She shall produce a certificate before joining the duties to the effect that she has only one living spouse. A person having more than one living spouse shall not be eligible for appointment to the post offered unless the Government after being satisfied that there are special grounds for doing so, exempt her from this condition.
5. She shall not be allowed to apply for any post outside the department for a period of at least five years.
6. She shall not claim seniority on the basis of these orders. Her seniority shall be determined in accordance with the relevant Service Rules and instructions issued by the State Government from time to time.

7. In other matters, not specifically mentioned in this communication, she shall be governed by the Civil Services Rules as applicable to Haryana Government Employees and such orders/instructions as may be issued by the Government from time to time.
8. She shall produce her original certificates relating to educational qualification, experience and other relevant documents before the concerned District Education Officer, who shall verify their genuineness before permitting her to join.
9. This appointment is subject to the condition that in case she has not produce medical fitness certificate and got verified her character and antecedents verified by the concerned authorities at the time of their initial appointment in the aided schools than concerned District Education Officer will ensure that she shall submit her medical fitness certificate first duly issued by the concerned Civil Surgeon only then she should join as TGT Punjabi in the concerned school. District Education Officer concerned will also give character and antecedents verification forms to her and after getting the same filled up by them, the same be sent to the office of Director Elementary Education Haryana through a special messenger within a week positively. This will be the personal responsibility of the concerned District Elementary Education Officer.
10. She shall be governed by the Haryana School Education (Group-C) State Cadre Service Rules, 2012 in case of TGT Punjabi.
11. If at any time during the course of her temporary appointment, any of the appointee desires to resign, she shall be required to give one month's clear notice or forfeit, in lieu thereof, her salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to her by the Government also in the case if it is proposed to terminate her services in lieu thereof the Government will be liable to pay her salary, including allowance for one month or for the period by which the notice falls short of one month.
12. No TA/DA shall be admissible to her for joining as TGT Punjabi.
13. If she gets an appointment as TGT Punjabi on the basis of her furnishing false or fraudulent information/facts/documents which are detected later on, she would be liable for termination of service without any notice.
14. The appointment under these rules shall be a fresh appointment made on the minimum of pay scale of that post, however, the salary of the employee appointed under these rules shall be protected as a measure personal and shall not be less than the salary which she is already drawing. The past service rendered shall not be counted for any other intents and purposes.
15. An employee appointed under these rules shall not be entitled to any promotion until she attains the age of superannuation.
16. An employee under these rules shall not be eligible for pension under the provisions of Haryana Civil Services (Pension) Rules, 2016. However, for the purpose of pension, an

employee so appointed shall continue to be governed under Haryana Aided Schools (Special Pension and Contributory Provident Fund) Rules, 2001, if appointed in the aided school before the 1st January, 2006. The employee appointed on or after the 1st January, 2006 and appointed in Service shall be governed by the National Pension Scheme (NPS).

17. An employee appointed under these rules shall be entitled for the amount of contribution towards Contributory Provident Fund/ National Pension Scheme alongwith interest liable to be paid by the concerned aided school management for the service rendered in the said school and the Management shall pay the same within a period of one month to the concerned quarters.
18. Arrears of any kind in respect of the employees who are working in aided schools and are appointed under these orders shall not be paid by the Government for the period prior to the date of appointment in the Service.
19. No grant-in-aid shall be payable to the aided schools in respect of the posts which have been taken over in the Service. However, the grant-in-aid shall continue to be reimbursed as per the provision made in rule 54 of the Haryana School Education Rules, 2003 for the remaining sanctioned posts on which incumbents are working in the aided school.
20. The leave account of the employees appointed under these rules shall start with a zero balance.
21. All other matters, not specifically mentioned in the Haryana Voluntary State Education Service Rules, 2017, shall be governed by the Haryana Civil Services Rules and Punjab Financial Rules as applicable to Haryana Government Employees and such rules and regulations as may have been, or may hereafter be adopted or made by the competent authority made under the Constitution of India or under any Law for the time being in force made by the State Legislature.

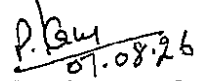
