Whereas, Sh. Jitender Singh and Smt. Sarla Devi have filed Civil Writ Petition No. 16930 of 2026 titled "Jitender Singh and another vs. State of Haryana & others" before the Hon'ble Punjab and Haryana High Court praying for a writ petition with praying there in to grant them the benefit of notional pay fixation and seniority from the date the candidates belongs to general category and other reserve categories were appointed against Advt. No. 1/1999.

The Hon'ble Punjab and Haryana High Court disposed of the said petition on 26.05.2026 with the following orders:

***"Notice of motion.***

***4. Ms. Tanushree Gupta, Adll. A.G. accepts notice on behalf of the respondents/State and submits that the pending representation, dated 25.03.2026, will be decided by respondent no. 2/Director General, Secondary Education by passing a speaking/reasoned orders in accordance with law within a period of six months.***

***5. In view of the statement made, learned counsel for the petitioners has no objections to the petition being disposed of in the term thereof.***

***6. Ordered accordingly.***

***7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of Rs. 50,000/- to the petitioners."***

In compliance with the aforesaid order, the representation dated 25.03.2026 submitted by Sh. Jitender Singh and Smt. Sarla Devi has been examined in detail. The petitioners have sought grant of benefits pertaining to seniority and pay fixation at par with the candidates selected through the HSSC with effect from the year 2002. The matter has been duly considered in light of the relevant records and applicable rules, and the claims made therein have been evaluated on their merits.

Whereas, the Department advertised the posts of Masters/Mistresses, Lecturers, DPEs, etc., vide Advertisement No. 1/99 for the General Category as well as other reserved categories, including the Physically Disabled (PwD) category. Subsequently, the posts earmarked for the Physically Disabled Category were withdrawn, and it was decided to fill the same through the Departmental Selection Committee. Thereafter, a total of 84 posts reserved for the Physically Disabled Category, comprising 27 posts of Lecturers (School Cadre) and 57 posts of Masters/Mistresses/DPEs, were

re-advertised vide dated 18.04.2001. The petitioners were declared successful for appointment to the posts of Lecturer on 17.02.2002.

However, the Department decided to conduct fresh interviews for the Physically Disabled candidates as three candidates selected for the posts of Lecturer were found to be ineligible for appointment on account of not possessing the domicile of the State of Haryana. The decision to hold fresh interviews for all candidates was challenged before the Hon'ble High Court by the selected candidates. The writ petition was decided on 28.08.2003, whereby the Hon'ble High Court directed the respondent-Department to issue appointment letters to the selected candidates in accordance with the selection list prepared by the Selection Committee. Consequently, all selected candidates were appointed to their respective posts on 22.10.2003.

Whereas, the posts of Lecturers advertised under Advertisement No. 1/99 for the General Category and other reserved categories were filled in April, 2004.

The posts of Masters/Mistresses/DPEs under the same advertisement i.e. Advt. No. 1/99 had already been recommended and filled in April, 2002.

Some of the candidates selected against the posts of Masters/Mistresses/DPEs in the Physically Handicapped category, who were issued appointment letters on 23.10.2003, approached the Hon'ble High Court by filing CWP No. 4344 of 2007, claiming that they were entitled to appointment with effect from the date on which candidates belonging to the General and other reserved categories had been appointed i.e. 01.04.2002.

The said writ petition was taken up for hearing on 22.03.2007 and was disposed of with directions to the Department to decide the legal notice submitted by the petitioners. Since the candidates selected under the General Advertisement for the posts of Masters/TGTs had been appointed vide orders dated 01.04.2002, whereas the petitioners belonging to the Physically Handicapped category were offered appointment only vide orders dated 23.10.2003, the Directorate of Elementary Education accepted the claim of the petitioners in CWP No. 4344 of 2007 by passing a speaking order bearing No. 17/62-07 HRM-I dated 27.11.2007. Accordingly, the petitioners were granted notional benefits, including seniority and pay fixation, with effect from 01.04.2002 i.e. the date when candidate of General Category (Masters/Mistresses/DPEs) were offered appointment.

Thereafter, other similarly situated candidates belonging to the Physically Handicapped category (Masters/Mistresses/DPEs) also approached the Hon'ble High Court by filing various writ petitions seeking

identical relief. The said writ petitions were allowed, and the Office of the Directorate of Elementary Education extended the benefit of notional seniority and notional pay fixation to such petitioners at par with the candidates appointed pursuant to Advertisement No. 1/99.

Whereas, the candidates who had applied for the posts of Lecturer under the General Category pursuant to Advertisement No. 1/1999 were offered appointments in April 2004. In contrast, the petitioners were offered appointments earlier, in October 2003, and have been granted seniority as well as all consequential financial benefits with effect from October 2003.

As the petitioner were already offered appointment prior to their counterparts of General Category against Advt. No. 1/99 and all actual benefits including pay fixation and Seniority were also granted from the date of October, 2003 over and above Lecturer/PGTs appointed against Advt. No. 1/99. Therefore, the claim of the incumbents, namely Sh. Jitender Singh and Smt. Sarla Devi, as made in their representation dated 25.03.2026, seeking benefits of seniority and pay fixation at par with the selectees of HSSC with effect from the year 2002, is not found to be tenable and is hereby rejected being devoid of merits.

It is ordered accordingly.
