Whereas, the names of the 38 (Rest of Haryana Cadre) selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Computer Science** vide recommendation no. RG-34/2022/12027 dated 25.03.2026 against Advt. No. 26/2023. While, recommending the name of the selected candidates, the Haryana Public Service Commission, Panchkula had made an observation as under:-

“The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 04.04.2026, but the candidate mention in below table remained absent during the verification of documents and no representation/request received from him for join the appointment process after intimate him telephonically also.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidate is not willing to serve as PGT Computer Science as he has failed to appear before Document Verification Committee for verification of his documents despite giving appropriate opportunities.

In view of the above, it has been decided to cancel his candidature for the post of PGT Computer Science against Advt. No. 26/2023. However, before

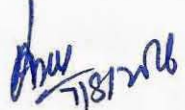

While, recommending the name of the selected candidate, the Haryana Public Service Commission, Panchkula had made an observation as under:-

“The Commission has interviewed and recommending the above candidate on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committee was constituted to verify the documents and all the recommended candidates were called for verification of their documents on 04.04.2026 and appointment letters were issued to candidates for the post of Post Graduate Teacher in the subject of Computer Science and directed to join their duties within 15 days at the allotted place till 18.05.2026 on the recommendations of Haryana Public Service Commission, Panchkula. But, these candidates were not joined within stipulated period and no request has been received from them for extension in joining period.

After considering the facts and circumstances of the case, it has been concluded that these candidates mention in table below are not willing to serve on the post of PGT Computer Science (Rest of Haryana Cadre) as they have not joined their duties to till date and no request for extension of joining time has been received from them.

In view of the above, it has been decided to cancel their candidature for the post of PGT Computer Science (Rest of Haryana Cadre). However, before cancellation of their candidature, a final opportunity is being granted to them to join his duties within 15 days, i.e., on or before **20.08.2026**. Failing this,

their appointment/candidature shall be cancelled without any further notice.
