No. 6/02-2026 PGT-1 (2)

Dated, Chandigarh, the 28.07.2026

Whereas, the names of the 02 selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Chemistry (Rest of Haryana)** vide recommendation no. RG-15/2024/8361 dated 01.01.2026 against Advt. No. 19/2024. While, recommending the name of the selected candidate, the HPSC, Panchkula had made an observation as under:-

“The Commission has interviewed and recommending the above candidate on the basis of the photocopies of documents submitted by them along with their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 03.02.2026. After completing the due process, appointment letters were issued to 02 eligible candidates who were appeared before document verification committee vide appointment order no. 6/02-2026 PGT-1(2) dated 05.03.2026 and directed to join within 15 days at allotted station. The appointed candidate namely Ms. Simran D/o Sh. Arjun Dev bearing Roll No. 13267 directed to join Government Senior Secondary School, Hisar (Patel Nagar) [1446] within 15 days at allotted station. However, she did not join his duties in stipulated period and requested for further extension. On her request further extension has been granted to her and directed to join their duties till 20.06.2026. But Ms. Simran D/o Sh. Arjun Dev bearing Roll No. 13267 was again failed to his duties till 20.06.2026 and no request has been received from her for extension in joining period.

After considering the facts and circumstances of the case, it has been concluded that Ms. Simran D/o Sh. Arjun Dev bearing Roll No. 13267, is not willing to serve on the post of PGT Chemistry (Rest of Haryana Cadre) as she has not joined her duties to date and no request for extension of joining time has been received from her side.

In view of the above, it has been decided to cancel his candidature for the post of PGT Chemistry (Rest of Haryana Cadre). However, before cancellation of his candidature, a final opportunity is being granted to him to join his duties within 15 days, i.e., on or before 20.08.2026. Failing this, her appointment/candidature shall be cancelled without any further notice.

No further opportunity will be granted.

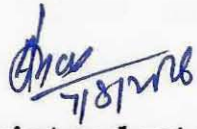
